APPROVING FINAL SUBDIVISION PLAT OF SUMMERSFIELD PLAT 3

WHEREAS, the final subdivision plat entitled Summersfield Plat 3, for land located east of E. 46th Street and southeast of Hubbell Avenue, to be developed by Summersfield LLC, 6900 Westown Parkway, West Des Moines, IA 50266, Joe Pietruszynski, Officer, was submitted to the Community Development Department on May 12, 2016; and,

WHEREAS, the City Plan and Zoning Commission approved the preliminary subdivision plat on January 19, 2006; and,

WHEREAS, subject to the conditions identified below, the said subdivision plat conforms to Iowa Code Sections 355.8, 354.6, and 354.11, and said subdivision plat conforms to the standards and conditions set forth in Chapter 106 of the Municipal Code of the City of Des Moines, Iowa; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. It is hereby determined that the subdivision plat identified above conforms to the PlanDSM: Creating Our Tomorrow Plan and the subdivision, with the required installation of public improvements, will not unduly burden public improvements in the area and will provide an appropriate balance of interests between current proprietors, future purchasers and the public interest.
- 2. The subdivision plat entitled Summersfield Plat 3 and subdivision bond number IAC586651 from Merchant's Bonding Company, in the amount of \$38,040 are hereby approved; the bond been received for the completion of the required public improvements and sidewalks within the plat and approved by the City Legal Department.
- 3. Upon satisfaction of the conditions set forth above, the Mayor and City Clerk are hereby authorized and directed to execute approval on all copies of said subdivision plat as appropriate.
- 4. The City Clerk is hereby directed to provide the approved subdivision plat, a certified copy of this resolution, the attorney's title opinion and the attachments to the plat to the Community Development Department for delivery to the County Auditor for recording by the plat proprietors. The City Clerk is hereby further directed to send a copy of the subdivision plat to the Board of Education, Century Link Communications, Mid-American Energy, Mediacom, Des Moines Water Works, U.S. Post Office Post Master, U.S. Post Office Technical Sales and Services, City Engineer, City Land Records, Public Works Street Department, Public Works Forestry Division, Fire Department, Police Department
