# SET HEARING FOR DES MOINES PARK AND RECREATION DEPARTMENT INITIATED REQUEST TO VACATE ROYAL PARK LOCATED AT 1809 8<sup>TH</sup> STREET

WHEREAS, on May 23, 2017, the Park and Recreation Board voted to approve a recommendation from the Des Moines Park and Recreation Department that the City Council of the City of Des Moines vacate Royal Park located at 1809 8<sup>th</sup> Street, Des Moines, Iowa; and

WHEREAS, there is no known current or anticipated public benefit or need for Royal Park that is proposed to be vacated, and the City will not be inconvenienced by the proposed vacation of said Royal Park as parkland.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating Royal Park, located at 1809 8<sup>th</sup> Street, Des Moines, Iowa, more specifically described as follows:

ALL OF LOT 10 AND THE NORTH HALF (1/2) OF LOT 9 IN BLOCK 10 OF THE OFFICIAL PLAT OF THE SOUTHWEST QUARTER (SW ¼) OF THE NORTHEAST QUARTER (NE ¼) OF SECTION 34, TOWNSHIP 79 NORTH, RANGE 24 WEST OF THE 5TH P.M. (SOMETIMES KNOWN AS POLK COUNTY HOMESTEAD AND TRUST CO'S ADDITION, AN OFFICIAL PLAT), ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

- 2. A public hearing shall be held on June 26, 2017, at 5:00 p.m. in the City Council Chamber, Richard A. Clark Municipal Service Center, 1551 E. Martin Luther King Jr. Parkway, Des Moines, Iowa. At that time, the City Council will consider the above-described proposed vacation ordinance during the public hearing.
- 3. The City Clerk is hereby authorized and directed to publish notice of said proposed vacation ordinance and hearing in the form hereto attached, all in accordance with Section 362.3 of the Iowa Code.


