RESOLUTION APPROVING URBAN RENEWAL DEVELOPMENT AGREEMENT WITH RACCOON VALLEY INVESTMENT COMPANY, L.C. FOR THE CONSTRUCTION OF A NEW HOTEL AT FLEUR DRIVE AND MCKINLEY

WHEREAS, on August 22, 2016, by Roll Call No. 16-1414, the City Council approved preliminary terms of agreement with Raccoon Valley Company, L.C. (Michael Coppola, Partner, 4521 Fleur Drive, Suite C, Des Moines, Iowa) is proposing to construct a new hotel with a minimum of 92 rooms to be located at Fleur Drive and McKinley. Total project costs are estimated at 13 million; and

WHEREAS, by said Roll Call No. 16-1414, the City Council also directed the City Manager to proceed with negotiation of a formal agreement consistent with the approved preliminary terms; and,

WHEREAS, the City Manager has negotiated an Urban Renewal Development Agreement (the "Agreement") with the Developer; and,

WHEREAS, the proposed Agreement and Conceptual Development Plan are on file and available for inspection in the office of the City Clerk; and,

WHEREAS, at its meetings on April 25, 2017 and June 13, 2017, the Urban Design Review Board expressed its consensus that the Council should approve of the financial assistance to be provided by the City and the design of the project subject to conditions specified by the Board.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council hereby makes the following findings in support of the proposed Agreement with the Developer:
- a) The Developer's obligations to construct the Improvements as provided by the Agreement furthers the objectives of the Urban Renewal Plan to provide additional housing, employment opportunities and tax base in the Metro Center Urban Renewal Project Area, and to preserve and create an environment which will protect the health, safety and general welfare of City residents.
- b) The economic development incentives for the creation of the employment opportunities and development of the Improvements are provided by the City to Developer pursuant to the Urban Renewal Law and Chapter 15A of the Code of Iowa, and Developer's obligations under this Agreement to construct the Improvements will generate the following public gains and benefits:
 (i) it will advance the improvement and redevelopment of the Metro Center Urban Renewal Area in accordance with the Urban Renewal Plan; (ii) it will encourage further private investment to reverse the pattern of disinvestment and declining property values in the surrounding area; and, (iii) it will further the City's efforts to retain and create job opportunities within the Urban Renewal Area which might otherwise be lost.

- The construction of the Improvements is a speculative venture and the construction and resulting c) benefits would not occur without the economic incentives provided by this Agreement.
- The City Council believes that the redevelopment of the Property pursuant to the Agreement, d) and the fulfillment generally of the Agreement, are in the vital and best interests of City and the health, safety, morals, and welfare of its residents, and in accord with the public purposes and provisions of the applicable state and local laws and requirements under which the project has been undertaken, and warrant the provision of the economic assistance set forth in the Agreement.
- The Conceptual Development Plan for the project, which is contained in the Agreement, is hereby 2. approved,
- The Urban Renewal Development Agreement between the City and Neighborhood Development 3. Corporation, is hereby approved. The Mayor and City Clerk are hereby authorized and directed to execute the Agreement on behalf of the City of Des Moines.
- Upon requisition by the City Manager or the City Manager's designee, the Finance Department shall 4. advance the installments on the Economic Development Grant pursuant to Article 4 of the Agreement.
- The City Manager or his designees are hereby authorized and directed to administer the Urban 5. Renewal Development Agreement on behalf of the City, including the filing of the Agreement, and to monitor compliance by the Developer with the terms and conditions of the Agreement. The City Manager is further directed to forward to City Council all matters and documents that require City Council review and approval in accordance with the Agreement.
