## **RESOLUTION TO APPROVE PAYMENT TO** THE GREATER DES MOINES PARTNERSHIP IN THE AMOUNT OF \$100,000 FOR CALENDAR YEAR 2016 AND PAYMENTS FOR CALENDAR YEARS 2017 AND 2018

WHEREAS, the Greater Des Moines Partnership coordinates a variety of programs that benefit Des Moines including but not limited to Choose Des Moines Communities, Downtown Community Alliance, Workforce Development, and production and operation of major events, markets and public amenities; and

WHEREAS, the City Manager recommends that the City continue its contributions to Greater Des Moines Partnership for provision of the Partnership programs to achieve the goals and measurements set out in the attached Council Communication; and

WHEREAS, the Greater Des Moines Partnership programs funded in part by the City further the public purposes of Iowa Code Chapter 15A to create new jobs and income and to retain existing jobs and income that would otherwise be lost in the City of Des Moines.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City Council hereby authorizes payment in the amount of \$100,000 from the Economic Development Enterprise Fund to the Greater Des Moines Partnership for provision of Partnership programs in calendar year 2016.

BE IT FURTHER RESOLVED that the City Manager is authorized to make payments from the Economic Development Enterprise Fund to the Greater Des Moines Partnership for the continued provision of Partnership programs in the amount of \$100,000 each year following calendar year 2017 and following calendar year 2018 provided that the City Manager has determined the Partnership has demonstrated success in achieving the program goals and measurements set out in the attached Council Communication.
