PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 5TH & KEO PARKING GARAGE ELEVATOR LOBBY HVAC; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS AIR-CON MECHANICAL CORPORATION, JAMES M. SHAFFER, PRESIDENT, \$52,817.00

WHEREAS, on May 22, 2017, under Roll Call No. 17-0850, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

5th & Keo Parking Garage Elevator Lobby HVAC, 04-2017-014

The project includes removal and replacement of three HVAC units, including necessary duct improvements, electrical upgrades, and drywall repair as specified in the contract documents including Plan File Nos. 564-045/051 at the 5th & Keo Parking Garage, Des Moines, Iowa.

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

BE IT FURTHER RESOLVED: That the City Council hereby authorizes the necessary road closures for the Project.
