## Des Moines Neighbors General Resolution 2017-02

WHEREAS Des Moines Neighbors is established as the umbrella organization for the neighborhood associations in the City of Des Moines;

WHEREAS the safety of our residents, our public safety officers, our neighborhoods, and our businesses is a primary concern for the neighborhood associations of Des Moines;

RECOGNIZING that the number of homicides in Des Moines has increased dramatically in 2017;

RECOGNIZING that the response times for calls and the average number of officers on the street at any given time is a major priority for the neighborhood associations of Des Moines;

RECOGNIZING that the number of new officers in each graduating class needs to constantly keep up with the number of officers retiring;

RECOGNIZING that officers taking on too much overtime can have a negative effect on both the community they serve and on the officers themselves;

RECOGNIZING that many community leaders supported the use of body cameras and more community policing, which the Des Moines Police officers have begun to implement;

RECOGNIZING that the City of Des Moines is expected to have unprecedented growth over the next several decades and that the City needs to begin planning for that population boom now to make sure that our public services are not strained later;

THEREFORE BE IT RESOLVED that Des Moines Neighbors supports an impartial study to analyze the police force and operations needed for the City of Des Moines today and what we will need in the coming decades for a city our geographic size within the next six months.
