SET HEARING FOR VACATION OF CITY ALLEY RIGHT-OF-WAY ADJOINING 1212 HUTTON STREET AND CONVEYANCE TO KATY S. BROWN FOR \$150.00

WHEREAS, on June 26, 2017, the City Council of the City of Des Moines, Iowa voted to accept the recommendation from the City Plan and Zoning Commission that the east-west alley right-of-way adjoining 1212 Hutton Street, hereinafter more fully described, be vacated, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated; and

WHEREAS, Katy S. Brown, owner of 1212 Hutton Street, has offered to the City of Des Moines ("City") the purchase price of \$150.00 for the vacation and purchase of the east west alley right-of-way adjoining her property at 1212 Hutton Street (herein "City Right-of-Way"), for incorporation into 1212 Hutton Street, which price reflects the fair market value of the City Right-of-Way as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the portion of the City Right-of-Way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines, Iowa, shall consider adoption of an ordinance permanently vacating the east-west alley right-of-way adjoining 1212 Hutton Street, legally described as follows, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated:

ALL OF THE EAST-WEST ALLEY RIGHT-OF-WAY LYING SOUTH OF AND ADJOINING LOT 53, ASHBROOK, AN OFFICIAL PLAT, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA; CONTAINING 1,827 SQUARE FEET.

SUBJECT TO EASEMENTS, COVENANTS AND RESTRICTIONS OF RECORD.

2. That if the City Council decides to vacate the above described right-of-way, the City further proposes to sell such vacated right-of-way, as legally described below, to Katy S. Brown for \$150.00, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated at buyer's expense:
