## SEVENTH AMENDMENT TO AGREEMENT BETWEEN THE CITY OF DES MOINES AND THE DES MOINES AIRPORT AUTHORITY FOR THE PROVISION OF CITY SERVICES

This Amendment is made as of the day of July, 2017 by and between the City of Des Moines, Iowa, municipal corporation, and the State of Iowa (the "City") and the Des Moines Airport Authority, an airport authority organized under Iowa Code Chapter 330A (the "Authority").

WHEREAS, the City and the Authority entered into an Agreement between the City of Des Moines and the Des Moines Airport Authority for the provision of City services dated November 1, 2011 pursuant to which the City agreed to provide certain services to the Authority; and

WHEREAS, on October 28, 2015, the Authority notified the City of the termination of the Agreement pursuant to its terms effective October 31, 2016; and

WHEREAS, the City and the Authority are presently engaged in negotiations with the intent of entering into a new services agreement, but have not completed those negotiations; and

WHEREAS, both the City and the Authority require additional time to complete their negotiations.

THEREFORE, the parties agree as follows:

1. Article 1 of the Agreement is amended to state:

This agreement terminates on August 31, 2017.

2. In all other respects, the Agreement shall otherwise remain in full force and effect as amended in Supplement No. 2 dated February 15, 2016.
