RESOLUTION CLOSING HEARING ON THE PROPOSED SECOND AMENDMENT TO THE URBAN RENEWAL PLAN FOR THE INGERSOLL-GRAND COMMERCIAL URBAN RENEWAL AREA AND ADOPTING SAME

WHEREAS, on July 9, 2012, by Roll Call No. 12-1113, the City Council approved the Urban Renewal Plan for the Ingersoll-Grand Commercial Urban Renewal Area (the "Urban Renewal Plan") which seeks to enhance private development within the proposed Ingersoll-Grand Commercial Urban Renewal Area though provision of infrastructure improvements and economic development assistance that will be provided in part with tax increment financing revenues to be generated in the urban renewal area; and,

WHEREAS, the City Manager has recommended approval of a proposed Second Amendment to the Urban Renewal Plan (the "Second Amendment") to include funding for the Ingersoll-Grand Streetscape - MLK Jr. Parkway to 28th Street project consisting of preliminary conceptual design, construction phasing plans, and cost estimates for the construction of the Ingersoll Avenue Streetscape from Martin Luther King Jr. Parkway to approximately 42nd Street, to permit that construction to be coordinated with reconstruction of the Ingersoll Avenue roadway from Martin Luther King Jr. Parkway to 31st Street; and,

WHEREAS, on June 12, 2017, by Roll Call No. 17-0974, the City Council resolved that a public hearing be held on July 24, 2017, at 5:00 p.m., in the City Council Chambers to consider the proposed Second Amendment, which is on file and available for inspection in the office of the City Clerk; and,

WHEREAS, the Urban Design Review Board reviewed the proposed Second Amendment at its regular meeting on June 13, 2017, and although a quorum of the members was not present, the consensus of the five members present was to support the proposed Second Amendment; and,

WHEREAS, notice of this public hearing containing the information required by Iowa Code §403.5(3), was published in the Des Moines Register on July 6, 2017; and,

WHEREAS, notice was given by ordinary mail to the Des Moines Public School District, Des Moines Area Community College, and Polk County of a consultation meeting held in the OED Conference Room, at the City Administration Building at 1:15 p.m., on July 27, 2017; and,

WHEREAS, the City has received no requests from the Des Moines Public School District, Des Moines Area Community College, or Polk County for any modification to the division of tax increment revenues proposed by the Second Amendment; and,

WHEREAS, the public hearing has now been opened and all persons and organizations desiring to be heard regarding the proposed Second Amendment to the Urban Renewal Plan have been given the opportunity to be heard; NOW THEREFORE,
