WHEREAS, on November 23, 2015 under Roll Call No. 15-1944, the City Council approved a private construction contract in the amount of \$11,000.00, between Elder Corporation, Jared R. Elder II, President, 5088 E. University Avenue, Des Moines, IA, 50327 - as Contractor, and Neighborhood Development Corporation, Glenn F. Lyons, Executive Director, 3209 Ingersoll Avenue, Suite 205, Des Moines, IA, 50312 - as Owner, for construction of Storm Sewer Improvements described as storm sewer manhole at 2249 S.W. 9th Street and storm sewer cross-run extending east across S.W. 9th Street, north of Davis Avenue, as per Plan File No. 561-190, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


