APPROVING PERMIT AND FACILITY USE AGREEMENT WITH PREMIER EVENT MANAGEMENT, LLC FOR GRAY'S LAKE PARK AND MEREDITH, KRUIDENIER AND SOUTHWEST CONNECTOR TRAILS AND FORMER RAILWAY RIGHT-OF-WAY TO THE SOUTH OF THE SOUTHWEST CONNECTOR TRAIL FOR THE DES MOINES TRIATHLON

WHEREAS, the City of Des Moines is the owner of Gray's Lake Park and the Meredith, Kruidenier and Southwest Connector Multi-Use Recreational Trails ("Trails"); and

WHEREAS, Premier Event Management, LLC (PEM) is hosting the Des Moines Escape Triathlon in Des Moines on September 3, 2017 ("the Des Moines Triathlon"); and

WHEREAS, PEM desires to stage the swim, bike and run events within Gray's Lake Park and to use a portion of the Meredith, Kruidenier and Southwest Connector Trails for the run event, and to use a portion of the former railroad right-of-way property to the south of Gray's Lake for a golf cart shuttle service and storage of trailers with event supplies; and

WHEREAS, Park and Recreation Department staff have negotiated a Permit and Facility Use Agreement with PEM to allow use of the above described City park and recreational facilities to allow PEM to stage the Des Moines Escape Triathlon, a copy of which is on file in the City Clerk's Office; and

WHEREAS, the City Council recognizes that such use of the above described facilities will be beneficial to the citizens of the City of Des Moines.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Permit and Facility Use Agreement, a copy of which is on file in the City Clerk's Office, is hereby approved subject to approval by the City Manager Office of the insurance requirements, and the Mayor is authorized and directed to execute such Agreement on behalf of the City and City Clerk is directed to attest to his signature.
