HONORABLE MAYOR AND MEMBERS OF THE DES MOINES CITY COUNCIL

Re: Report to Council

Pursuant to the authority and direction of Council authorizing the City Attorney to settle claims, lawsuits and workers compensation actions for a total sum not to exceed \$5,000, I submit to Council the following summary report of settlements made:

PROGRESSIVE INSURANCE \$1,268.03 for subrogation claim of Shay Meh due to an auto accident on July 24, 2016, when a City ambulance was backing in a parking lot and struck Claimant's parked vehicle.

MIDAMERICAN ENERGY \$145.75 damage to an overhead line during street repair at 117 East Maxwelton on June 12, 2015.

KEN THEDFORD \$568.43 for repair of auto damaged due to an auto accident on June 13, 2017, when a City police vehicle struck Claimant's parked vehicle.

JERRY FREEMAN \$1,594.82 for repair of Claimant's sewer line at 1428 Wayne Street because the City did not reconnect the homeowner's lateral line after relining the City main.

GERALD BUDDE \$251.22 for a sewer backup damage at 1845 & 1847 E. Creston Avenue on May 2, 2017, as the result of a blockage in the City main.

JEREMY WATKINS-HARRIS \$704.64 for auto damage repair as the result of a City vehicle backing into Claimant's vehicle while at a stop sign on June 6, 2017.

ROBERT & COLEEN SWISHER \$2,668.62 for sewer backup damage at 3300 S.E. 4th Court on June 4, 2017, as a result of a blockage in the City main.

JACKIE LARSON \$30.00 for damage to Claimant's mailbox which was caused by a City snowplow in December 2016.

DEANNA RICHARDSON \$650.00 for damage to Claimant's fence which was the result of a City tree limb falling at 1349 Harrison Avenue on June 17, 2017.

JIMMIE WILLIAMS \$30.00 for damage to mailbox at 3729 E. 24th Ct., which was damaged by a City tree limb falling on it July 24, 2017.

TRAVELERS \$3,500.00 for City's deductible for the claim of Caitland Brumbaugh for damage caused by a City snow plow in an accident occurring on January 20, 2014.

NANCY RAMSEYER \$200.00 for auto damage to Claimant's vehicle which was a result of a City crew spraying anti-dust fluid on a gravel road and failing to post warning signs on July 18, 2017.

MIDAMERICAN ENERGY \$994.12 for damage to an overhead line at 1601 Countyline Road, caused by a City dump truck while in the process of raising its box on January 24, 2017.

SAFECO INSURANCE CO. OF AMERICA \$3,940.65 for the subrogation claim of Donna Elgin for auto damage as the result of a City truck backing into Claimant's legally parked and unoccupied vehicle on August 25, 2016.

ENTERPRISE RENT-A-CAR \$458.34 for rental car expense of Claimant Lee Smith, due to an auto accident occurring on May 25, 2017 when a City police vehicle rear-ended Claimant's vehicle.

BRAD'S COLLISION CENTER \$2,204.25 for auto repair of Claimant Lee Smith's vehicle due to an auto accident occurring on May 25, 2017 when a City police vehicle rear-ended Claimant's vehicle.

KARL CHEVROLET \$1,899.72 for auto repair of Claimant Lyndsey Moon's vehicle due to an auto accident occurring on June 9, 2017, when a City vehicle changed lanes and struck Claimant's vehicle.

ENTERPRISE RENT-A-CAR \$208.46 for rental car expense of Claimant Lyndsey Moon, due to an auto accident occurring on June 9, 2017, when a City vehicle changed lanes and struck Claimant's vehicle.

BERKE TUINSTRA \$600.00 for repayment of money Claimant claims was in his wallet when he was arrested on April 27, 2017.

GARY KRUSE \$4,999.00 for settlement of a worker's compensation claim. Mr. Kruse sustained a work-related injury to his left shoulder on August 16, 2016, while working for the City in its Sewer Maintenance Division.

MIDAMERICAN ENERGY \$196.43 for damage to an overhead power line at 2549 E. 23rd Street on February 28, 2017, due to a City solid waste truck lifting its mechanical arm into the line which was hanging higher than the required minimum height.

NATIONWIDE AGRIBUSINESS INSURANCE CO. \$1,386.40 for subrogation claim of Claimant Terry Kofron's damaged vehicle as a result of an auto accident involving and EMS vehicle and Claimant's parked and unoccupied vehicle on June 7, 2017.

COUNTRY FINANCIAL \$2,446.08 for subrogation claim of Mateo and Marla Del Carmen's damages due to a sewer backup in their home at 2748 Logan Avenue, which was the result of a City sewer crew cleaning the sewer line on July 27, 2017.

CENTURYLINK \$3,483.83 for damage to a properly marked buried cable at 11th and Madison Avenue on June 7, 2017, caused by a City excavation crew.

ROBERT WADDELL \$2,257.47 for auto damage as the result of a City Public Works vehicle making an improper turn and striking Claimant's vehicle on May 11, 2017.

RICHARD PUTMAN \$896.00 for damage to Claimant's garage and fence at 4045 4th Street, caused by overspray of an oil-based liquid to control dust in an alleyway on July 6, 2017.

KARMON LONG \$1,481.35 for auto damage as the result of a City police vehicle striking Claimant's parked and unoccupied vehicle on August 31, 2017.

JOHN & CRYSTAL NIEBAUM \$328.62 for damage to Claimant's vehicle as a result of a City police officer opening his car door, the wind catching it, hitting Claimant's vehicle and causing the damage on August 3, 2017.
