  - The Fort Des Moines Restoration Project as amended by the First Amendment to the Amended and Restated Development Agreement with FDM Development Partnership, LLLP, as designee of Fort Des Moines Restoration, LLC, approved by the City Council on May 8, 2017, by Roll Call No. 17-0775; and,
- to update the Financial Condition Report to include the amended projects identified above; and,

WHEREAS, on September 11, 2017, by Roll Call No. 17-1559, the City Council resolved that a public hearing be held on October 9, 2017, at 5:00 p.m., in the City Council Chambers to consider the proposed Fourth Amendment; and,

WHEREAS, the Urban Design Review Board reviewed the proposed Fourth Amendment at its regular meeting on September 26, 2017, and the members voted 7-0 in support of a motion to recommend approval of the Fourth Amendment; and,
