NOT TO EXCEED \$201,427.18**



Dear Mr. Lewis:

The enclosed drawing shows MidAmerican Energy Company's proposal to install (14) new street lights for the above project. The applicant charge for this work is \$201,427.18. *(Since this project is over \$100,000 you are required by tariff to pay actual costs upon completion of the work. If the project is less than the original estimate you will be refunded the difference and conversely you will be charged any amount above the estimated cost stated in this agreement.)* This proposal is valid for 90 days and if MidAmerican Energy Company construction has not commenced within 12 months it may be voided.



MidAmerican Energy Company assumes no liability for private facilities that are not located.
