AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114 Traffic & Vehicle Regulations, Sections 1114-2597.1, 14-2600, 114-2614, 114-3466, 114-3508, 114-3862, 114-3867, 114-3926, 114-3929, 114-4078.1, as summarized below. **DES MOINES TRAFFIC REGULATION CHANGES**

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes as follows:

- A. Parking meter changes for streets surrounding the new Confluence on Third development.
- B. Revised parking restrictions on Mulberry Street from 9th Street to 10th Street.
- C. Adding two-hour parking meters and parking restrictions on E 2nd Street from E Locust Street to E Grand Avenue.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2600, 114-2614, 114-3466, 114-3862, 114-3867, 114-3926, 114-3929, repealing Section 114-3508, and by adding and enacting new Sections 114-2597.1 and 114- 4078.1, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2597.1. East Second Street—East Locust Street to East Grand Avenue.**

East Second Street, on the east side, from a point 160 feet north of East Locust Street to East Grand Avenue, no parking any time.

East Second Street, on the west side, from East Locust Street to East Grand Avenue, no parking any time.


