AMENDED AND SUBSTITUTED POLICE SERVICES AGREEMENT BETWEEN THE CITY OF DES MOINES AND THE DES MOINES SKYWALK ASSOCIATION

WHEREAS, the Des Moines Police Department and the Des Moines Skywalk Association desire to enter into an agreement for security services; and

WHEREAS, the Des Moines City Council approved an agreement on January 23, 2017 through Roll Call 17-0116, however that agreement was not signed by the Des Moines Skywalk Association;

WHEREAS, the agreement amends and replaces all prior agreement on the matters agreed to herein and;

WHEREAS, the Skywalk Association agrees to pay the City of Des Moines for one-half of the annualized salary for a top step senior police officer and the one-half annualized benefits estimated for the said top step senior police officer;

WHEREAS, modifications can be made only by the mutual written consent of all parties;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the Iowa Code Chapter 28E Agreement between the City and the Des Moines Skywalk Association, on file in the Office of the City Clerk is hereby approved and the Mayor is hereby authorized and directed to execute such Agreement on behalf of the City and the City Clerk is hereby authorized and directed to attest to his signature.

AMENDED AND SUBSTITUTED POLICE SERVICES AGREEMENT BETWEEN THE CITY OF DES MOINES AND THE DES MOINES SKYWALK ASSOCIATION

This Agreement is made and entered into this ______ day of ______, 2017, by and between THE CITY OF DES MOINES, IOWA, an Iowa municipal corporation, hereinafter referred to as the "CITY", and the DES MOINES SKYWALK ASSOCIATION, a non-profit corporation under Chapter 504, Code of Iowa, hereinafter referred to as the "ASSOCIATION."

RECITALS OF FACT

- A. The membership of the ASSOCIATION is comprised of owners of real estate and businesses with direct or indirect access to the Skywalk System. The CITY, the ASSOCIATION, and Polk County Iowa have entered into an Amended Skywalk Security and Surveillance Chapter 28E Agreement dated the 16th day of December, 1996 and filed with the Polk County Recorder on January 28, 1997 at book 7565 pp. 471-495. Under the terms of the 28E Agreement the ASSOCIATION "intends to provide, for the benefit of the public and its members, a security and surveillance program in the City Skywalk System which may include, without limitation, on-duty uniformed security personnel, police officers of the City, and installation of remote control visual equipment and monitoring stations." Section 1 of the 28E Agreement states in part that "the City and DMSA [Des Moines Skywalk Association] will enter into a separate contract regarding provision of, and payment for, such on-duty police officers."
- B. The CITY, through its Police Department, has offered its on-duty police officers for security and surveillance in the Skywalk System and is willing to train additional officers as are required to provide the level of service herein contemplated.

TERMS OF AGREEMENT

In consideration of the mutual promises and covenants contained herein, the parties agree as follows:

1. Description of Services.

The ASSOCIATION and the CITY will work together to determine the security and surveillance services to be provided by police officers of the Des Moines Police Department, which services shall be consistent with good police practices. Such services shall be provided by the assigned police officer(s) according to their responsibilities as required of police officers by the Des Moines Police Department Patrol Services Bureau Standard Operating Procedures. The CITY shall provide police trip reports and crime mapping data for the area encompassing the skywalk system in the standard format used by the police department for such reporting when requested by the ASSOCIATION.

2. Number of Officers.

The number of full-time, on-duty police officers required by the ASSOCIATION to provide security and surveillance in the present Skywalk System is on the basis of one officer 8 hours per day, 5 days per week, which may be staffed by one full-time police officer 40 hours a week or a combination of sequential police officers to obtain 40 hours of security and surveillance per week. As the hours of operation of the Skywalk System change, as the Skywalk System expands, and with experience gained over time by the ASSOCIATION and the Police Department, the number of full-time, on-duty police officers required under this Agreement may be changed by mutual agreement and may be a fractional equivalent representing less than full-time service. The compensation for any change in the number of hours of service will be reflected in the monthly billing statement.

3. Selection of Officers.

The police protection services under this Agreement can and will be provided by Des Moines Police Officers selected by the CITY such that the customary level of police protection of the City outside the Skywalk System is fully maintained. If the parties agree that more officers are required than the one presently contemplated, the CITY will promptly, upon written notice from the ASSOCIATION, begin training such additional officers as may be required.

4. Compensation.

The ASSOCIATION will pay the CITY for police officers services provided under this Agreement one-half of the amount determined as follows:

- a) An annualized salary for a top salary step senior police officer.
- b) An annualized benefit estimate for the said top salary step senior police officer.
- c) The resulting product shall be multiplied by the number of officers employed per section 2 of this agreement and then divided by 12 to determine the monthly payment.

Salary and benefits information, including dates when effective will be provided to the ASSOCIATION and attached to his Agreement as Attachment A and when adopted by the City Council of Des Moines from time to time in keeping with applicable collective bargaining agreements. Attachment A will be updated annually or more frequently to coincide with then applicable collective bargaining agreements.

In no event shall the amount to be paid by the ASSOCIATION to the CITY in any one fiscal year of the CITY exceed by five percent (5%) the amount that would have been owing by the ASSOCIATION to the CITY in the immediately preceding fiscal year had the same level of police services as is contemplated for the current fiscal year been provided in the immediately preceding fiscal year, unless this restriction is waived in writing by the ASSOCIATION.

5. Administration.

The ASSOCIATION will administer the overall security and surveillance program in the Skywalk System. The obligations of the Police Department within that program shall be governed by the Standard Operating Procedures Manual. The Police Department shall have exclusive control over the choice of police officers assigned to the Skywalk System and over matters which are ordinary and necessary to their employment as police officers of the CITY and which are ordinary and necessary to coordinate and fulfill their duties under the security and surveillance requirements of the Standard Operating Procedures Manual. It is understood and agreed that, while the primary responsibility of said police officers will be to provide police protection within the Skywalk System, the Police Department in its sole discretion shall have the right to reassign such officers elsewhere within the city on a temporary basis in extraordinary situations in which the Police Department would normally require the assistance of other officers who have another primary assignment or when it is recalling off-duty officers to supplement its normal on-duty force.

6. Default.

Neither party shall be considered in default on its obligations unless the other party has given it written notice of such violation and it has not cured the violation within fourteen days of its receipt of such notice; provided, such party shall not be considered in default if the nature of its violation is such that it cannot reasonably be cured within said fourteen days, so long as within said fourteen days such party has begun and diligently pursues to completion appropriate action to cure the violation. The remedy for default may be the termination of this Agreement at the election of the non-defaulting party.

7. <u>Term</u>.

This Agreement shall be coterminous with the Chapter 28E Agreement referenced above in Recitals of Fact part A of this Agreement, and any extensions, substitutions, amendments, or renewals thereof; provided, however, either party may terminate this agreement by giving notice of termination on or before March 31st of any year, whereupon such termination shall be effective as of the end of June 30th immediately following such notice.

8. Liability.

The CITY shall be liable for any injuries or damages to the public, private persons, or property arising out of the actions of its police officers while working in the Skywalk System to the same extent that it is liable for the actions of its on-duty police officers generally. The CITY shall indemnify and hold harmless the ASSOCIATION, its officers, directors and members, from and against any such liability, including the cost of defense.

9. Modifications.

This Agreement can be modified only by the mutual written consent of all parties.

10. Notices.

Any notice permitted or required by this Agreement will be effective when presented in writing personally or deposited in the United States mail, postage prepaid, by registered mail, return receipt requested, to the other parties at the address specified below or as changed in accordance with notice given pursuant to this paragraph:

11. Previous Agreements.

This Agreement amends and replaces all prior agreements on the matters agreed to herein.

12. Miscellaneous.

Time is of the essence of this Agreement. This agreement shall be interpreted and enforced in accordance with the laws of the state of Iowa. In the event of litigation to interpret or enforce this Agreement, the prevailing party shall, in addition to all remedies available at law or in equity, be entitled to recover costs and attorney fees. If any provision of this Agreement is deemed illegal because of its scope or breadth, a court of competent jurisdiction shall be empowered to reform the provision in order to comport with the maximum lawful scope or breadth that most nearly achieves the original intention of the parties.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be duly executed, in two counterparts, each of which shall constitute one in the same instrument.

STANDARD OPERATING PROCEDURE

(Revised 15 June 2017)

SKYWALK OFFICER

The Skywalk officer program is staffed by a Senior Police Officer or Police Officer and is supervised by a Sergeant assigned to the Neighborhood Based Service Delivery Unit (NBSD). The Skywalk officer serves as a point of contact for downtown residents, visitors, businesses and police personnel as it pertains to Des Moines downtown Skywalk system.

- A. This SOP is created under the authority of the Chief of Police.
- B. Working in a cooperative effort with the skywalk association, civic groups, businesses, landlords, residents and other City Departments to identify and resolve various skywalk issues.
- C. Maintaining regular contact with all interested parties to keep abreast of changes in issues, concerns and leadership within the skywalk system. This includes information sharing with the skywalk association private security contractors daily.
- D. Attend skywalk meetings and functions, provide assistance, information and participation as a member of the skywalk group.
- E. Act as a resource for police department personnel, and provide support and assistance in resolving issues in and around the skywalk.
- F. Have quarterly meetings between skywalk association and department administration to discuss issues and review crime data pertinent to the skywalk.
- G. Serve as an ambassador for the police department.
- H. Assigned hours, days worked and other responsibilities will be determined by the Section and Division commanders under the discretion of the Chief of Police.
