

ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE dissolving Sherman Hill Historic Street Lighting Self-Supported Municipal Improvement Districts.

WHEREAS, the City of Des Moines passed Ordinance Number 13,488 on June 2, 1997, establishing the Sherman Hill Historic Street Lighting Self-Supported Municipal Improvement District, and,

WHEREAS, the City of Des Moines passed Ordinance Number 13,531 on October 6, 1997 establishing the Sherman Hill Historic Street Lighting Self-Supported Municipal Improvement District #2, and,

WHEREAS, on October 9, 2017, in Roll Call Number 17-1769, the City Council adopted Ordinance No.15,618 creating the Sherman Hill Self-Supported Municipal Improvement District which consists of the combined properties of Sherman Hill Historic Street Lighting Self-Supported Municipal Improvement District and Sherman Hill Historic Street Lighting Self-Supported Municipal Improvement District #2 plus additional properties and expanded authority; and,

WHEREAS, Ordinance Number 15,618 is intended to replace both Ordinance Numbers 13,488 and 13,531; and,

WHEREAS, Iowa Code section 386.5 provides that the City may dissolve and terminate Self-Supported Municipal Improvement Districts with an affirmative vote of three-fourths of the members of the Council.


BE IT ORDAINED, by the City Council of the City of Des Moines, Iowa:

Sec. 1. That the Self-Supporting Municipal Improvement Districts created by Ordinance Numbers 13,488 and 13,531 are hereby dissolved and terminated pursuant to Iowa Code section 386.5.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

Sec. 3. The City Clerk is hereby authorized and directed to cause a certified copy of this ordinance to be recorded in the office of the Polk County Recorder, and a copy thereof to be filed with the Polk County Auditor.
