RESOLUTION TO RECEIVE AND FILE POLICE/IT FACILITY PLANNING STUDY AND REFER TO CITY MANAGER TO COOPERATE WITH ENVIRONMENTAL CLEANUP EFFORTS AND ANALYZE POSSIBLE ACQUISITION OF THE DICO PROPERTY AS THE FUTURE LOCATION FOR THE NEW POLICE DEPARTMENT BUILDING FACILITY

WHEREAS, on May 23, 2016, by Roll Call No. 16-0830, the City Council approved a professional services agreement with RDG IA, Inc. d/b/a RDG Planning & Design (hereinafter Consultant) for planning services for the Police Department and Information Technology (IT) Department Facility Planning Study; and

WHEREAS, at the Work Session on December 12, 2016, the Consultant presented an interim report to the City Council which showed that IT and Police Department current and future growth needs could be met in an "Expand-in-Place" option on land currently used by the Police Department and on adjacent property; and

WHEREAS, the Consultant reviewed other potential sites within the identified downtown core district and determined that the northern portion of the DICO property near the intersection of Fleur Drive and Martin Luther King Jr. Parkway could satisfy the long-term growth needs of the Police Department and, at a Work Session on November 20, 2017, the Police/IT Facility Planning Study was presented to the City Council which identified the northern portion of the DICO site, if otherwise viable, as the preferred site; and

WHEREAS, the Environmental Protection Agency and Iowa Department of Natural Resources are collaborating on required analysis and potential actions that may allow re-use of the DICO property, including planned actions of building removal, soil evaluation, settlement with current owner and study of the groundwater treatment system including compatibility with proposed development.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Police/IT Facility Planning Study is hereby received and filed.
