HONORABLE MAYOR AND MEMBERS OF THE DES MOINES CITY COUNCIL

Re: Report to Council

Pursuant to the authority and direction of Council authorizing the City Attorney to settle claims, lawsuits and workers compensation actions for a total sum not to exceed \$5,000, I submit to Council the following summary report of settlements made:

SHOTTENKIRK FORD COLLISION CENTER \$1,365.32 for repair of damage to Claimant Scott Fees's vehicle, which was struck by a City vehicle in the WRA parking lot on August 21, 2017.

RICHARD & PHYLLIS CACCIATORE \$72.25 for paint removal from Claimants' vehicle, which was the result of unmarked fresh paint at Beaver and Hickman on August 23, 2017.

BRIAN BROMMEL \$1,778.15 for repair of damage to Claimant's parked vehicle, which was struck by a City police car while it was backing up on September 22, 2017.

NANCY GUTHRIE \$549.18 for a sewer backup damage at 2904 Caulder Avenue on April 30, 2017, due to a blockage in the City main.

DONNA BRYANT \$895.00 for reimbursement of the cost of repairs made to a vehicle sold to Claimant by the City and which was later found to be stolen. The vehicle was returned to the rightful owner.

AMERICAN FAMILY INSURANCE \$1,762.52 for payment of subrogation claim of Claimant Synice Miller, whose vehicle was damaged when a squad car rear-ended it on December 15, 2016.

EDWARD WALSH \$1,050.00 for replacement cost of Claimant's handguns which were recovered and subsequently destroyed without proper notification to Claimant.

DOUG MEYERS \$1,908.59 for auto damage which was the result of Claimant driving through unmarked wet paint at Forest Avenue and Beaver Avenue on August 22, 2017.

JASON SITES \$378.00 for auto damage to Claimant's vehicle due to paint overspray which occurred while a City employee was marking locations in a parking garage related to a construction project on October 2, 2017.

PROGRESSIVE INSURANCE \$3,861.57 for damage to Claimants Abel and Janis Zeleke's vehicle from an auto accident with a City fire truck on September 27, 2017.

VINCENT & ANTONIETTE DeANGELIS \$394.32 for replacement of Claimant's storm door glass, which was broken while EMS crew was moving patient out Claimant's residence on October 16, 2017.

SCOTTY'S BODY SHOP \$1,714.02 for auto damage caused by a Public Works vehicle striking Claimant Devin Schmitt's parked and unoccupied vehicle on September 2, 2017.

TRAVELERS INSURANCE \$5,000.00 for insurance deductible for the personal injury claim of Jaysen McCleary, who sustained an injury on January 4, 2014, while attempting to assist in lifting a heavy toter to a solid waste truck, when the lifting arm broke and the toter fell on his head.

TANNER THACKER \$422.37 for refund of a purchased ATV, and subsequent ignition switch. The ATV was purchased from the Des Moines Police Department, was subsequently found to have a lien, so Claimant was not able to license it.

JOLENE PURDY \$3,700.94 for a sewer backup at 3100 Cleveland Avenue on April 11, 2017, caused by a blockage in the City main.

ERIC GANNON \$1,978.67 for damage to Claimant's vehicle due to a WRA dumpster blowing into his vehicle and causing damage on December 13, 2017.

CENTURYLINK c/o JNR ADJUSTMENT COMPANY \$698.34 for damage to Claimant's manhole casting caused by a City sewer crew at 19th Crocker Streets on July 20, 2017.

RICHARD CLARK \$2,379.77 for auto damage caused by a City police car on December 19, 2017, when the squad car was backing up and struck Claimant's parked and unoccupied vehicle.
