WAIVING CONDITION PRECEDENT IN THE AMENDED AND RESTATED DEVELOPMENT AGREEMENT FOR THE IOWA EVENTS CENTER HOTEL, APPROVING IRA TRUST INDENTURE AND SERIES D CERTIFICATE GUARANTEE AND OTHER PROJECT DOCUMENTS

WHEREAS, by Roll Call No. 15-0269 of February 23, 2015, the City Council of the City of Des Moines, approved Preliminary Terms of Agreement for City assistance to the development of the full-service Convention Center Hotel connected to the Iowa Events Center ("Hotel"); and

WHEREAS, by Roll Call No. 15-1913 of November 9, 2015, the City Council approved a Development Agreement with Polk County, Iowa and IEC Hotel Corporation for development of the Hotel; and

WHEREAS, by Roll Call 16-0517 of March 21, 2016, the City Council approved an Amended and Restated Development Agreement with IEC Hotel Corporation and Polk County, Iowa, which, included various undertakings by the City, including an obligation that the City guarantee Series D Certificates to be issued by the IEC Hotel Corporation, subject to the condition precedent that said guarantee contain a provision allowing the City to call Series D Certificates at any time; and

WHEREAS, it is now determined that due to interest costs and other considerations, the interests of the City are better served by waiving the above-referenced condition precedent in favor of alternate call provisions; and

WHEREAS, a form of guarantee for the Series D Certificates has been prepared for Council consideration and approval;

WHEREAS, a form of IRA Trust Indenture between the City, Polk County, Iowa and IEC Hotel Corporation for the deposit and disbursement of Iowa Reinvestment Act ("IRA") revenues has been prepared for Council consideration and approval.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa;

1. That the condition precedent provided in Section 5.2(d) of the Amended and Restated Development Agreement approved by this Council on March 21, 2016 relating to the call of Series D Certificates at any time is hereby waived.
