ORDINANCE NO. _____

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2909, 114-3033, 114-3441.05 and 114-3451, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2909, 114-3033, 114-3441.05 and 114-3451, relating to traffic and vehicle regulations, as follows:

Sec. 114-2909. East Thirty-ninth Court--~~Mattern Avenue to East Madison Avenue~~ Fortieth Street.

East Thirty-ninth Court, on the west side, from East Sheridan Avenue to a point 50 feet south thereof, no parking any time.

East Thirty-ninth Court, on the west side, from East Sheridan Avenue to Hull Avenue, no parking any time.

East Thirty-ninth Court, on the west side, from Easton Boulevard to a point 75 feet south thereof, no parking no time.

East Thirty-ninth Court, on the west side, from a point 75 feet south of Easton Boulevard to a point 135 feet south thereof, school passenger loading and unloading 7:00 a.m. to 4:00 p.m. school days, 30-minute limit.

East Thirty-ninth Court, on the east side, from Mattern Avenue to East Sheridan Avenue, no parking any time.

East Thirty-ninth Court, on the west side, from East Ovid Avenue to ~~East Madison~~ Seneca Avenue, no parking any time.

East Thirty-ninth Court, on the east side, from East Seneca Avenue to East Fortieth Street, no parking any time.

Sec. 114-3033. East Broad Street--~~South Union Street to Southeast Tenth Street.~~

East Broad Street, on the south side, from South Union Street to Southeast Seventh Street, no parking any time.

East Broad Street, on the south side, from ~~Indianola Avenue~~ Southeast Eighth Street to Southeast Eighth Court, no parking any time.

East Broad Street, on the north side, from Southeast Fifth Street to a point 50 feet east thereof, no parking any time.

East Broad Street, on the north side, from Southeast Eighth Court to Southeast Tenth Street, no parking any time.

Sec. 114-3441.05. East Luster Lane--Southeast Thirty-third Street to East Havens Avenue.

East Luster Lane, on the north side, from East Twenty-third Street to and including the cul-de-sac at East Havens Avenue, no parking any time.

East Luster Lane, on the south side, from a point 75 feet north of East Havens Avenue to East Havens Avenue, no parking any time.

East Luster Lane, on the east side, from Southeast Nineteenth Court to Bloomfield Road, no parking any time.

Sec. 114-3451. East Madison Avenue--First Street to dead end east of East Forty-second Street.

East Madison Avenue, on the south side, from First Street to a point 100 feet west of East Eighth Street, no parking any time.

East Madison Avenue, on the north side, from a point 100 feet west of Cornell Avenue to a point 85 feet east of Cornell Avenue, no parking any time.

East Madison Avenue, on the north side, from a point 125 feet west of North Union Street to a point 275 feet east thereof, no parking any time.

East Madison Avenue, on the north side, from a point 100 feet west of East Eighth Street to East Tenth Street, no stopping or standing 7:00 a.m. to 5:00 p.m. school days.

East Madison Avenue, on the south side, from a point 100 feet west of East Eighth Street to East Tenth Street, no stopping or standing.

East Madison Avenue, on the south side, from East Tenth Street to McDonald Street, no parking any time.

East Madison Avenue, on the north side, from a point 50 feet west of East Fourteenth Street to a point 50 feet east of East Fourteenth Street, no parking any time.

East Madison Avenue, on the north side, from East Twenty-third Street to East Twenty-fourth Court, no parking any time.

East Madison Avenue, on the south side, from East Twenty-third Street to a point 60 feet east, no parking any time.

East Madison Avenue, on the south side, from East Twenty-fifth Street to East Twenty-ninth Street, no parking any time.

East Madison Avenue, on the north side, from East Twenty-ninth Street to East Thirty-second Street, no parking any time.

East Madison Avenue, on the south side, from East Thirty-second Street to a point 50 feet west thereof, no parking any time.

East Madison Avenue, on the north side, from East Fortieth Street to ~~a point 50 feet east of East Forty-second Street~~ Briarcliff Drive, no parking any time.


East Madison Avenue, on the south side, from Briarcliff Drive to East Forty-first Street, no parking any time.
