HONORABLE MAYOR AND MEMBERS OF THE DES MOINES CITY COUNCIL

At its February 8, 2018 meeting, the Building and Fire Code Board of Appeals passed a motion to amend its rules and regulations by amending sections relating to time and place of meetings, agenda and minutes, appellant and citizen participation, actions and election of officers, and by deleting matters not on the agenda, and by renumbering various sections. The purpose of the amendments was to bring the rules and regulations in line with Des Moines City Code and State Law.

At the April 9, 2018 City Council meeting, the Council approved the amendments to the rules and regulations, but struck the word "appointed" from Section B, item 3 regarding quorum. By striking such term, the rules and regulations are in direct conflict with Des Moines City Code Section 26-121(c). The Legal Department respectfully requests the City Council reconsider its prior action by rescinding its prior approval in Roll Call no. 18-0567 and approve the amendments as presented.
