RECOMMENDATION FROM COUNCIL MEMBER GATTO TO REAPPOINT LAURA GIBSON TO THE ACCESS ADVISORY BOARD, SEAT 7, FOR A 4 YEAR TERM COMMENCING JUNE 15, 2018, AND EXPIRING JUNE 15, 2022, AND TO WAIVE THE PROHIBITION ON HAVING TWO EMPLOYEES OF THE SAME EMPLOYER ON THE BOARD

WHEREAS, Council Member Joe Gatto has recommended that Laura Gibson, be reappointed to Seat 7 on the Access Advisory Board for the remainder of the four year term ending on June 15, 2018; and,

WHEREAS, Seat 7 on the Access Advisory Board is required to be held by a person who owns or is employed by a business or agency which primarily provide services to persons with disabilities, and Laura Gibson meets this requirement by being employed as the Director of Operations for Central Iowa Center for Independent Living; and,

Whereas, Reyma McCoy McDeid is also employed by Central Iowa Center for Independent Living and is a member of the Access Advisory Board; and,

WHEREAS, Section 2-1054(c) of the Des Moines City Code generally prohibits two members of any City board or commission from being employed by the same company unless a waiver is granted by the City Council; and,

WHEREAS, Council Member Joe Gatto has requested that the City Council grant a waiver pursuant to Section 2-1054(f) to permit a second employee of Central Iowa Center for Independent Living to serve on the Access Advisory Board.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that an exemption is hereby granted to allow two employees of Central Iowa Center for Independent Living to serve on the Access Advisory Board, and that Laura Gibson is hereby reappointed to Seat 7 on the Access Advisory Board effective May 1, 2018, for the four year term expiring on June 15, 2022.
