REJECT ALL BIDS ON
TOWER AND SHERIDAN PARK RESTROOMS
AND TO CLOSE THE HEARING ON THE PLANS, SPECIFICATIONS, FORM
OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE

WHEREAS, on April 23, 2018, under Roll Call No. 18-0667, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk for the construction of the following improvement:

Tower and Sheridan Park Restrooms, 11-2018-008

The improvement includes the construction of a new 500 square foot restroom building at Tower Park and a new 220 square foot restroom building at Sheridan Park, including limited site work preparation, foundation excavation, new concrete foundations, concrete flatwork, masonry partitions, metal doors and frames, aluminum stopped windows, exposed wood and standing seam metal roof system, painting, mechanical, plumbing and electrical systems; all in accordance with the contract documents, including Plan File Nos. 538-215/263, located in Tower Park at 4900 Hickman Road and Sheridan Park at 4000 East Hull Avenue, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law; and

WHEREAS, the Des Moines City Engineer, as the Engineer, recommends rejection of all bids because there were two bids submitted and only one of the two bids could be read which was submitted by Burkett Construction, LLC, Andrew Burkett, Owner, 2341 Carver Road, Winterset, Iowa, 50273, in the amount of \$450,410.00 which was 31% over the project estimate of \$343,800.00, and exceeded the budget. Engineering staff contacted the four other plan holders that indicated they would be prime bidders to find out why they did not submit a bid, and two indicated there were busy and would be more interested in bidding later in the summer and the other two said the project was not something they were interested in. Park and Recreation staff has reevaluated the project and project completion and have asked Engineering staff to meet with the design architects to make changes to the project and to bid later in the summer and to extend the completion date. The Des Moines City Engineer, as the Engineer, recommends project revisions and rebidding the project later this summer of 2018.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be and is hereby **CLOSED**.


