## **RESOLUTION REDEDICATING EAST MARKET STREET BETWEEN SOUTHEAST** 5<sup>TH</sup> STREET AND SOUTHEAST 6<sup>TH</sup> STREET FOR RIGHT-OF-WAY PURPOSES

WHEREAS, on December 17, 1990, by Roll Call No. 90-5495, the City Council of the City of Des Moines passed Ordinance No. 11,587 vacating East Market Street right-of-way between Southeast 5<sup>th</sup> Street and Southeast 6<sup>th</sup> Street; and

**WHEREAS**, the previously vacated Market Street right-of-way between Southeast 5<sup>th</sup> Street and Southeast 6<sup>th</sup> Street is now needed for roadway and pedestrian way purposes and requires rededication as public right-of-way.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. Previously vacated East Market Street between Southeast 5<sup>th</sup> Street and Southeast 6<sup>th</sup> Street, legally described as follows, is hereby rededicated as public right-of-way.

EAST MARKET STREET RIGHT-OF-WAY LYING NORTH OF AND ADJOINING THE SOUTH 273.0 FEET OF MARKET SQUARE, OF TOWN OF DE MOINE, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

2. The City Clerk is hereby authorized and directed to forward a certified copy of this resolution to the Real Estate Division.

3. The Real Estate Division is authorized and directed to forward the certified copy of this resolution to the Polk County Recorder for the purpose of causing said document to be recorded.
