
## APPROVING COMPLETION AND ACCEPTANCE OF THE SIGNALS IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, IEC HOTEL, BETWEEN BAKER ELECTRIC, INC. AND IEC HOTEL CORPORATION

WHEREAS, on September 11, 2017 under Roll Call No. 17-1543, the City Council approved a private construction contract in the amount of \$115,957.70, between Baker Electric, Inc., Britt Baker, CEO, 111 Jackson Avenue, Des Moines, IA, 50315 - as Contractor, and IEC Hotel Corporation, Gerad D. Neugent, Board President, 5000 Westown Parkway, West Des Moines, IA, 50266 - as Owner, for construction of Signals Improvements described as signal installations at the northwest, northeast, and southeast corners at 5th and Park Avenues, the southeast corner at 5th Avenue and Center Street, and associated miscellaneous items, as shown in the contract documents and Plan File Nos. 572-130/132, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.




