## REQUEST BY DES MOINES TRANSLOAD SERVICES, LLC FOR CITY COUNCIL INITIATION OF VACATION OF RIGHT-OF-WAY ADJOINING 200 SOUTHEAST 15<sup>TH</sup> STREET AND NORTH OF 1101 RACCOON STREET

WHEREAS, Des Moines Transload Services, LLC (operator/contract purchaser) is pursuing vacation and conveyance of City-owned right-of-way adjoining the real property located at 200 Southeast 15<sup>th</sup> Street and north of the real property located at 1101 Raccoon Street, described as follows, for assemblage for the construction and operation of a railroad transloading facility and for rail track connection and stormwater detention purposes:

- (A) Southeast 15th Street from East Market Street to East M.L. King Jr. Parkway;
- (B) Southeast 11<sup>th</sup> Street from Raccoon Street north to the Iowa Interstate Railroad;
- (C) North/south alley between Southeast 11<sup>th</sup> Street and Southeast 12<sup>th</sup> Street from the BNSF Railroad north to the Iowa Interstate Railroad;
- (D) Southeast 12th Street from the BNSF Railroad north to the Iowa Interstate Railroad; and

WHEREAS, City policy requires that an application to privately initiate the vacation of a public right-of-way must be accompanied by the written consent of the owners of all property adjoining the right-of-way proposed to be vacated; and

WHEREAS, Des Moines Transload Services, LLC has failed to obtain the consent to the vacation of the right-of-way from the adjoining property owners, notwithstanding that the right-of-way appears to be no longer providing any vehicular ingress or egress; and

WHEREAS, Des Moines Transload Services, LLC has requested that the City Council initiate the process to consider the vacation of this right-of-way.

**NOW, THEREFORE, BE IT RESOLVED,** by the City Council of the City of Des Moines, Iowa, that the vacation of the City-owned right-of-way adjoining the real property located at 200 Southeast 15<sup>th</sup> Street and north of the real property located at 1101 Raccoon Street, as identified above, is hereby referred to the Plan and Zoning Commission and City staff for review and recommendation to the City Council.
