RESOLUTION HOLDING HEARING ON REQUEST FROM UTRAJ, LLC TO REZONE 2216 EAST 14TH STREET

WHEREAS, on June 25, 2018, by Roll Call No. 18-1069, the City Council received a communication from the City Plan and Zoning Commission advising that at a public hearing held on June 7, 2018, its members voted 12-0 in support of a motion to recommend DENIAL of a request from Utraj, LLC (purchaser), represented by Utkarsh Mahajan (officer), to rezone property at 2216 East 14th Street ("Property") from Limited "C-2" General Retail and Highway-Oriented Commercial District, with uses restricted to those allowed in the "C-1" Neighborhood Retail Commercial District and used car sale lots, to a Limited "C-2" General Retail and Highway-Oriented Commercial District with the ability to sell packaged liquor as part of a Limited Retail/Food Sales Use or Gas Station/Convenience Store Use; and

WHEREAS, on June 25, 2018, by Roll Call No. 18-1069, it was duly resolved by the City Council that the application of Utraj, LLC to rezone the Property, legally described as follows, be set down for hearing on July 9, 2018 at 5:00 p.m. in the Council Chamber at the Council Chambers:

LOTS 85, 86, 87 AND 88, EXCEPT THAT PART CONDEMNED FOR HIGHWAY PURPOSES, IN DEMOTTE'S ADDITION TO CAPITAL PARK, AN OFFICIAL PLAT, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY.

WHEREAS, due notice of said hearing was published in the Des Moines Register, as provided by law, setting forth the time and place for hearing on said proposed rezoning; and
