## RESOLUTION IN SUPPORT OF A WORKFORCE HOUSING TAX CREDIT (WHTC) BENEFIT APPLICATION TO BE SUBMITTED TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY (IEDA) BY INDIGO DAWN, LLC FOR A SCATTERED SITE HOUSING REHABILITATION PROJECT AT 1124 13TH STREET, 1311 LAUREL STREET AND 1345 7TH STREET

WHEREAS, Iowa Code Section 446.19A permits cities to acquire tax sale certificates for abandoned property assessed as residential property or as commercial multifamily property or vacant residential lots at a tax sale without paying the taxes then due, to obtain the assignment of outstanding tax sale certificates by payment to the certificate holder the amount then due to redeem the certificate, and to further assign said certificates, all for the purpose of encouraging the acquisition and rehabilitation of abandoned dwellings and lots; and

WHEREAS, on February 5, 2018, by Roll Call No. 18-0204, the City Council approved acquisition of the vacant and abandoned properties locally known as 1124 13<sup>th</sup> Street and 1311 Laurel Street by tax sale deed and directed Community Development staff to distribute a Request for Proposal (RFP) to developers to acquire and renovate said properties based on an approved rehabilitation plan; and

WHEREAS, on May 16, 2018, the City Community Development staff distributed a Request for Proposal (RFP) to redevelopers of single family housing in order to select a developer to complete the necessary development on said properties for housing use; and

WHEREAS, Indigo Dawn, LLC, represented by Chaden Halfhill, President, responded to the RFP and was selected by the reviewers as the recommended developer for the purpose of said redevelopment; and

**WHEREAS**, the real property locally known as 1345 7<sup>th</sup> Street has been vacant in excess of six months and is non-conforming to the current single-family zoning, and Indigo Dawn, LLC is in the process of submitting a rezoning application to allow a duplex use on the property; and

WHEREAS, Indigo Dawn, LLC has requested City support for its application to the Iowa Economic Development Authority ("IEDA") for state tax incentives under the Workforce Housing Tax Credit Program for a four-unit scattered site housing rehabilitation project including all of the afore-mentioned properties; and

WHEREAS, successful completion of the Indigo Dawn, LLC project requires funding from a number of sources, including an award of Iowa Workforce Housing Tax Credit benefits in the estimated amount of \$104,600; and

WHEREAS, the application requirements for the Workforce Housing Tax Credit Program include a requirement for the submission of a resolution in support of the housing project by the community where the housing project will be located, which requirement is intended to be satisfied by this Roll Call and resolution; and

WHEREAS, a further application requirement for the Workforce Housing Tax Credit Program is documentation of local matching funds pledged for the project in an amount not less than \$1,000 per dwelling unit, which is expected to be covered by City of Des Moines' residential tax abatement (residential ten-year declining tax abatement).
