WHEREAS, the low dollar compliant bid was received from B & G Construction, 1735 E. Park Ave., Des Moines, IA 50320, Gary Bowen, Owner; and

WHEREAS, funding is available from CD041042/Neighborhood Inspections, for an annual estimated cost of \$75,000.00; and

WHEREAS, the Procurement Administrator and the Community Development Department recommends approval of the low dollar compliant bid for board-up services,

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to B & G Construction, and further authorizes the Procurement Administrator to enter into an annual agreement renewable for two (2) additional twelve (12) month periods, with price increases complying with agreement terms.
