APPROVING EXCEPTION TO CITY'S REQUEST FOR PROPOSAL (RFP) PROCESS FOR GOOD CAUSE AND APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH CALHOUN-BURNS & ASSOCIATES, INC. FOR DESIGN AND CONSTRUCTION PHASE SERVICES FOR FLEUR DRIVE PASSAGEWAY, NOT TO EXCEED \$286,363

WHEREAS, on April 23, 2018, by Roll Call Number 18-0724, City Council approved the Intergovernmental 28E Agreement with Des Moines Water Works and Des Moines Water Works Park Foundation (hereinafter as "DMWWF") for construction and funding of the Fleur Drive Passageway; and

WHEREAS, the City Engineer recommends that the procurement of professional services for the Fleur Drive Passageway be exempted from the requirements of the Engineering Department's Request for Proposal (RFP) process and advertising requirement for good cause shown, pursuant to Section 2-726(b)(1)(a) of the Municipal Code of the City of Des Moines.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That good cause has been shown to exempt the procurement of design and construction phase services from the requirements of the Engineering Department's RFP process and advertising requirements of such Section.

BE IT FURTHER RESOLVED: That the Professional Services Agreement between the City of Des Moines and Calhoun-Burns and Associates, Inc., Michael Vander Wert, President, 1500 30th Street, West Des Moines, Iowa, 50266, for a total cost not to exceed \$286,363, based on hourly rates, to provide design and construction phase services for Fleur Drive Passageway, a copy to be placed on file in the office of the City Clerk upon final approval by the City Engineering Department and approval as to form by the Legal Department, be and are hereby approved subject to final approval as to form by the City Legal Department and final approval as to form by the City Engineering Department.
