ACCEPTING PROPOSAL OF CORNERSTONE GOVERNMENT AFFAIRS, INC. TO PROVIDE FEDERAL GOVERNMENT RELATIONS CONSULTING AND LOBBYING SERVICES AND AUTHORIZING CITY MANAGER TO EXECUTE AGREEMENT FOR THE PROVISION OF SAME

WHEREAS, Federal policy, legislation and funding issues have significant impact on City services and infrastructure; and

WHEREAS, the City is certain to benefit from the assistance of effective lobbyists located in Washington, D.C. representing the City's interests; and

WHEREAS, the City Manager's Office requested the Finance Department Procurement Division to solicit proposals for professional federal government affairs services and the Procurement Division solicited bids for such services by advertisement and mailing RFP No. V18-072 Federal Government Affairs Services to 25 potential proposers with 3 proposals received; and

WHEREAS, the Evaluation and Selection Committee determined that the proposal submitted by Cornerstone Government Affairs, Inc., 800 Maine Avenue SW, Washington, DC 20024, was the highest scoring proposal and recommends such proposal to the City Council for award of contract; and

WHEREAS, an agreement to provide such services has been negotiated by the Government Relations Director with Cornerstone Government Affairs, Inc., at an annual cost of \$120,000, for an initial term of one year with up to three additional 1 year renewal terms, a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the proposal submitted by Cornerstone Government Affairs, Inc., for Federal Government Affairs Services is hereby accepted and the City Manager is hereby authorized and directed to execute an agreement with Cornerstone Government Affairs, Inc., at an annual cost of \$120,000, for an initial term of one year with up to three additional 1 year renewal terms, a copy of which is on file in the City Clerk's Office, and the City Clerk is authorized and directed to attest to the City Manager's signature.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to renew the agreement for up to three 1 year renewal terms.
