



**DES MOINES TRAFFIC REGULATION CHANGES**

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes as follows:

- A. Stop sign addition at Indiana Avenue and Maine Street.
- B. Addition of no parking any time area on west side of 5th Avenue, north of Court Avenue.
- C. Parking and loading zone additions related to opening Grand Avenue Bridge.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2235, 114-2628, 114-3244 and 114-3267, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2235, 114-2628, 114-3244 and 114-3267, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2235. Indiana Avenue.**

Indiana Avenue, at Maine Street, stop.  
Indiana Avenue, from the west line of Second Avenue to the east line of Sixth Avenue, stop.  
Indiana Avenue, at Eighth Street, stop.

**Sec. 114-2628. Fifth Avenue--Wagner Street to Mulberry Street.**

Fifth Avenue, on the west side, from Cherry Street to Wagner Street, no parking any time.  
Fifth Avenue, on the west side, from Cherry Street to a point 130 feet a point 105 feet north of Cherry Street to a point 25 feet north thereof, no parking any time.  
Fifth Avenue, on the east side, from Wagner Street to Court Avenue, no parking any time.

**Sec. 114-3244. Grand Avenue--Des Moines River to Second Avenue.**

~~Grand Avenue, on the south side, from a point 200 feet east of Second Avenue to a point 75 feet east thereof, loading zone.~~  
~~Grand Avenue, on both sides the south side, from Second Avenue to a point 200 feet east thereof, no parking any time.~~ the Des Moines River, reserved for City of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.  
~~Grand Avenue, on the north side, from Second Avenue to a point 350 feet east thereof, no parking any time.~~  
~~Grand Avenue, on the north side, from a point 200 feet east of Second Avenue to a point 130 feet east thereof, no parking any time.~~  
~~Grand Avenue, on the south side, from a point 275 feet east of Second Avenue to a point 55 feet east thereof, no parking any time.~~

**Sec. 114-3267. East Grand Avenue--Des Moines River to Robert D Ray Drive.**

East Grand Avenue, on the north side, from Robert D Ray Drive to a point ~~200~~ 180 feet west thereof, ~~no parking any time~~ commercial loading zone.


~~East Grand Avenue, on the north side, from a point 200 feet west of Robert D Ray Drive to a point 320 feet west thereof, permit parking only, 8:00 a.m. to 4:00 p.m., Monday through Friday.~~

~~East Grand Avenue, on the south side, from Robert D Ray Drive to a point 70 feet west thereof, no parking any time.~~

East Grand Avenue, on the south side, from a point ~~110~~ 200 feet west of Robert D Ray Drive to a point ~~90~~ feet west thereof, ~~no parking anytime~~ the Des Moines River, reserved for City of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
