## HOLD HEARING FOR VACATION OF A PORTION OF VAN BUREN STREET RIGHT-OF-WAY BETWEEN SOUTHEAST $4^{\rm TH}$ STREET AND SOUTHEAST $5^{\rm TH}$ STREET FOR THE SE $4^{\rm TH}$ STREET AND VAN BUREN STREET STORM WATER PUMP STATION PROJECT

WHEREAS, vacation of a portion of Van Buren Street right-of-way between Southeast 4th Street and Southeast 5th Street is required for construction of the SE 4th Street and Van Buren Street Storm Water Pump Station Project, subject to the reservation of easements for all existing utilities in place until such time as they are abandoned or relocated; and

WHEREAS, said portion of Van Buren Street is undeveloped and inactive right-of-way and the City Engineer and City Traffic Engineer have determined that there is no known current or future public need for the portion of Van Buren Street right-of-way proposed to be vacated, and the City will not be inconvenienced by the vacation of said property.

WHEREAS, on August 6, 2018, by Roll Call No. 18-1332, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed vacation of said portion of Van Buren Street right-of-way be set for hearing on August 20, 2018, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to vacate a portion of Van Buren Street right-of-way between Southeast 4<sup>th</sup> Street and Southeast 5<sup>th</sup> Street was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed vacation, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed vacation of a portion of Van Buren Street right-of-way between Southeast 4th Street and Southeast 5th Street for the SE 4th Street and Van Buren Street Storm Water Pump Station Project, as described herein, are hereby overruled and the hearing is closed.
