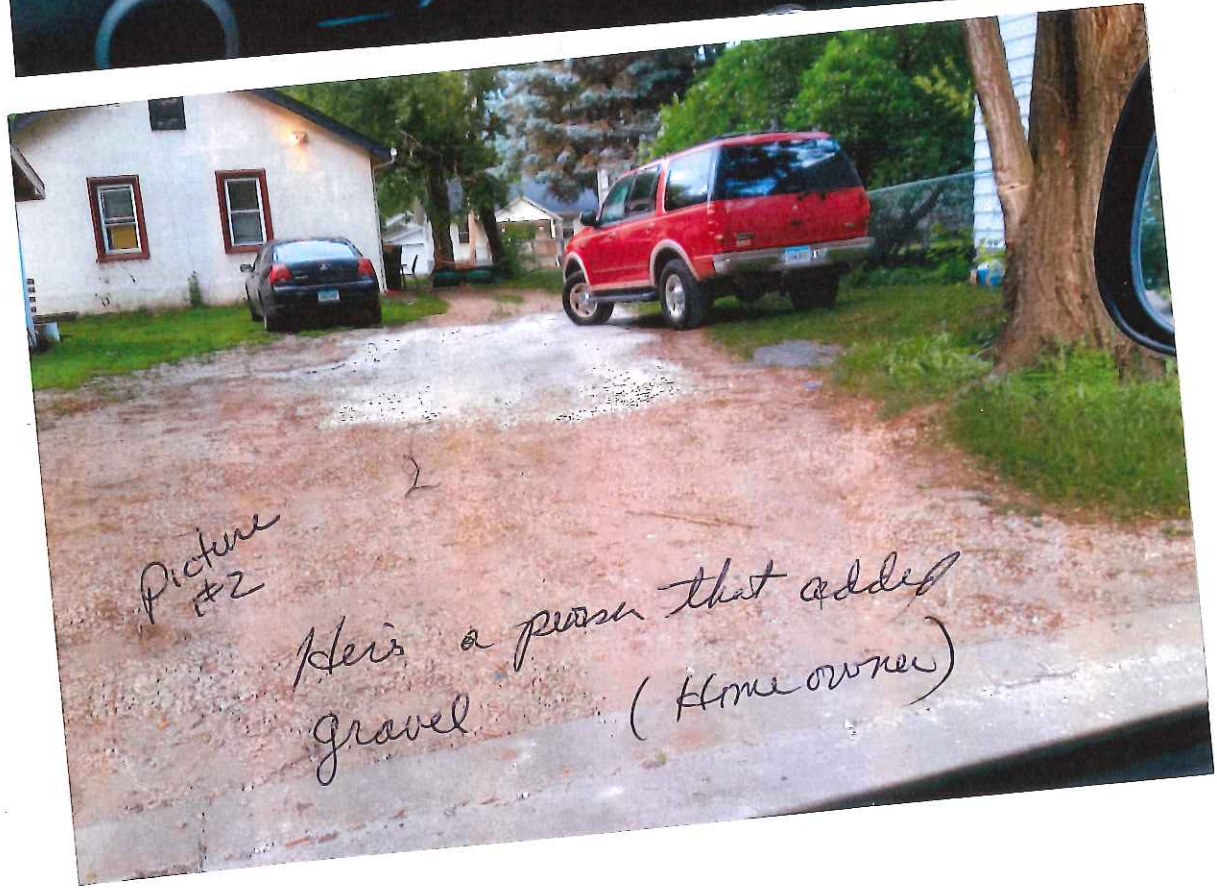
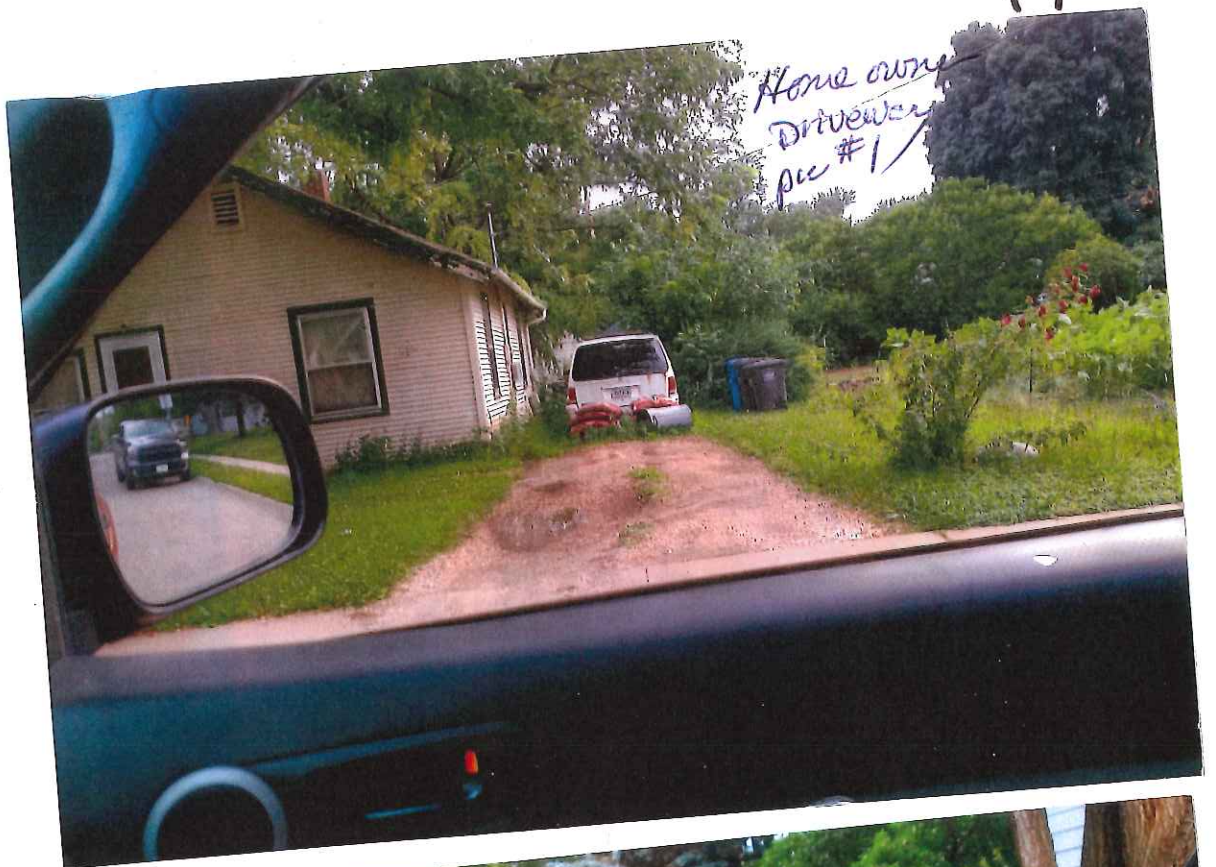

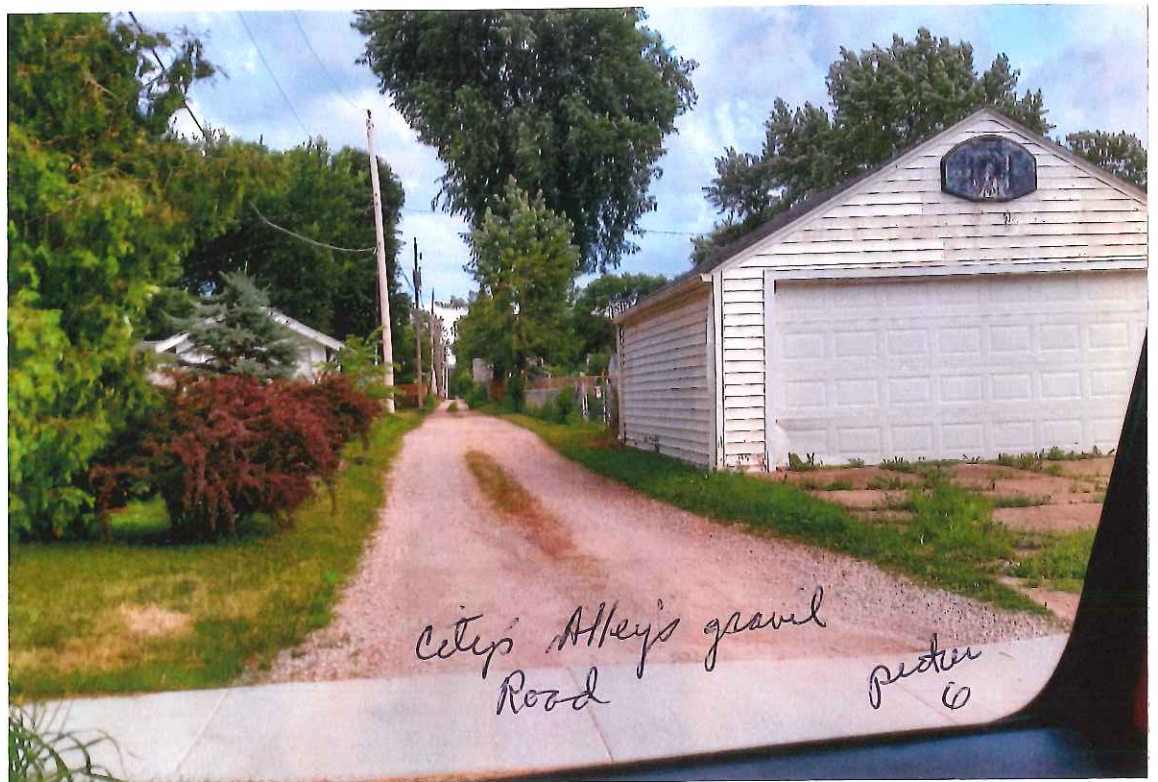
city Alley path #3
