BETWEEN GATOR EXCAVATING INC. AND SILVER OAK, INC.

WHEREAS, on October 9, 2017 under Roll Call No. 17-1720, the City Council approved a private construction contract in the amount of \$109,956.00, between Gator Excavating, Inc., Kevin Henter, President, 3100 S.E. Miede Drive, Grimes, IA, 50111 - as Contractor, and Silver Oak, Inc., Ronald R. Grubb, President, 10430 New York Avenue, Suite C, Urbandale, IA, 50322 - as Owner, for construction of Sanitary Sewer Improvements described as sanitary sewer improvements located on E. Kenyon Avenue between S.E. 24th Street and S.E. 25th Street, and St. Andrews Circle east of S.E. 25th Street, to serve Carman Estates Plat 7, as shown on Plan File Nos. 587-165/184, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

Kenyon Avenue between S.E. 24th Street and S.E. 25th Street, and St. Andrews Circle east of S.E. 25th Street, to serve Carman Estates Plat 7, as shown on Plan File Nos. 587-165/184, is hereby acknowledged and that said Sanitary Sewer Improvements are hereby accepted.
