REQUEST TO JOIN THE NORTH RACCOON RIVER WATERSHED COALITION AND APPROVING AND AUTHORIZING THE EXECUTION OF A 28E AGREEMENT WITH VARIOUS ENTITIES TO BECOME A PARTY OF THE NORTH RACCOON RIVER WATERSHED COALITION

WHEREAS, flooding and water quality issues related to the North Raccoon River Watershed have impacts on Des Moines residential and commercial properties, and

WHEREAS, city staff recommends it is necessary to coordinate various cities, counties and soil and water conservation districts and their various improvements within the North Raccoon River Watershed through a joint Watershed Management Coalition; and

WHEREAS, the cities of Storm Lake, Lake View, Lake City, Perry, Van Meter, Lidderdale, Grimes, Lohrville, Lakeside, Glidden, Newell, Nemaha, Clive, Fonda, and Laurens; the Soil and Water Conservation Districts of Buena Vista County, Calhoun County, Webster County, Green County, Boone County, Polk County, Madison County, Sac County, Carroll County, Pocahontas County, and Dallas County; and the counties of Buena Vista, Pocahontas, Greene, Dallas, Carroll, Sac, Calhoun, Polk, Webster, and Boone have entered into a 28E agreement to create the North Raccoon River Watershed Management Coalition pursuant to Section 466B.22 of the Iowa Code; and

WHEREAS, the 28E agreement allows for the City of Des Moines to become a party subject to approval by a two-thirds vote of the North Raccoon River Watershed Coalition Board;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA, that:

1. It hereby formally requests to join and become a party of the North Raccoon River Watershed Coalition and the City Manager is authorized and directed to communicate such request to the North Raccoon River Watershed Coalition; and
