## RESOLUTION APPROVING PRELIMINARY TERMS FOR AN URBAN RENEWAL DEVELOPMENT AGREEMENT WITH NELSON DEVELOPMENT FOR THE CONSTRUCTION OF A HOME2 SUITES HOTEL ALONG UNIVERSITY AVENUE, BETWEEN 26TH AND 27TH STREET ACROSS FROM DRAKE UNIVERSITY.

WHEREAS, Nelson Development (Alexander Grgurich, 505 5th Avenue, Des Moines, IA 50309) (the "Developer") proposes to construct an 86,300-square-foot, 5-story hotel/retail building along University Avenue, between 26th and 27th Street, across from Drake University that are presently parking lots; and,

WHEREAS, the project is proposed to house a Home2 Suites hotel with lobby and amenities on the first floor and 124 hotel rooms on floors 2-5. The building will also include 11,000 square feet in retail/restaurant space on the ground floor facing University Avenue; and,

WHEREAS, the project is anticipated to cost \$27 million and would begin construction in Spring 2019; and,

WHEREAS, in conjunction with the creation of a new urban renewal are for economic development, the proposal will encourage the location and expansion of a commercial enterprise and enhance, these underutilized parcels; and,
