**AUTHORIZING SUBMITTAL OF FEDERAL SURFACE TRANSPORTATION BLOCK GRANT (STBG) AND TRANSPORTATION ALTERNATIVE PROGRAM (TAP) FUND FISCAL YEAR (FY) 2023 APPLICATIONS TO THE DES MOINES METROPOLITAN PLANNING ORGANIZATION (MPO)**

WHEREAS, the City of Des Moines is a full member of the Des Moines Area Metropolitan Planning Organization (MPO); and

WHEREAS, the Federal Surface Transportation Block Grant (STBG) Program and the Federal Transportation Alternatives Program (TAP), provides funding to local jurisdictions for the construction of eligible projects; and also

WHEREAS, the programs are administered by the Des Moines Area MPO that prioritizes and ranks all project applications;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the City Manager is hereby authorized to submit applications to the Metropolitan Planning Organization for Federal Surface Transportation Block Grant (STBG) and Transportation Alternative Program (TAP) funds for the following projects.

**STBG Project Applications**

1. Walnut Street Bridge over the Des Moines River (Bridge Repair/Replacement Project)
2. Grand Avenue – Martin Luther King Parkway to 28<sup>th</sup> Street (Repair Project)
3. Southeast Connector – SE 30th Street to US 65 Beltway (Roadway Project)
4. Intelligent Transportation Systems Upgrade (Transportation Optimization Project)


