RESOLUTION SETTING DATE OF PUBLIC HEARING ON THE PROPOSED URBAN RENEWAL PLAN FOR THE DRAKE URBAN RENEWAL AREA

WHEREAS, the City Council desires to consider the use of its urban renewal powers to enhance private development through the provision of infrastructure improvements and economic development assistance within the proposed area south of University Avenue between 27th Street and the half-block east of 26th Street plus the University Avenue right of way between 23rd and 34th streets; and,

WHEREAS, the City Manager has prepared a proposed Urban Renewal Plan for the Drake Urban Renewal Area (the "proposed urban renewal plan") which is on file and available for inspection in the office of the City Clerk; and

WHEREAS, the proposed urban renewal plan seeks to enhance private development within the proposed Drake Urban Renewal Area through provision of infrastructure improvements and economic development assistance that will be provided in part with tax increment financing revenues to be generated in the urban renewal area; and,

WHEREAS, the Urban Design Review Board is scheduled to review the proposed urban renewal plan at its regular meeting on December 11, 2018, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council; and,

WHEREAS, the City Plan and Zoning Commission is scheduled to review the proposed urban renewal plan at its regular meeting on December 20, 2018, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. A public hearing shall be held before the City Council to consider the proposed Urban Renewal Plan for the Drake Urban Renewal Area at 5:00 p.m. on January 14, 2019, in the City Council Chambers.
- 2. The City Clerk is authorized and directed to publish notice of said public hearing in the form attached hereto as Exhibit A in the Des Moines Register not less than four nor more than 20 days before the date of hearing, as required by Iowa Code sections 386.3(4) and 362.3.
