



ORDINANCE NO. _____

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-320.01, 114-361.01, 114-361.06, 114-1104, 114-1441, 114-1554.01, 114- 1997, 114-2181, 114-2611, 114-2836, 114-2913, 114-2923, 114-2926, 114-3066, 114-3131, 114-3540, 114-3609, 114-3740 and 114-3744, and by repealing Section 114- 1894, and by adding and enacting new Section 114-1848.5, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-320.01, 114-361.01, 114-361.06, 114-1104, 114-1441, 114-1554.01, 114- 1997, 114-2181, 114-2611, 114-2836, 114-2913, 114-2923, 114-2926, 114-3066, 114-3131, 114-3540, 114-3609, 114-3740 and 114-3744, and by repealing Section 114-1894, and by adding and enacting new Section 114-1848.5, relating to traffic and vehicle regulations, as follows:

Sec. 114-320.01. Prohibited left turns.

No person shall make a left turn with a vehicle at the following locations:

- (1) At the intersection of East Euclid Avenue and Des Moines Freeway (Interstate Highway 235), prohibiting left turns from westbound East Euclid Avenue to southbound ramp, and prohibiting left turns from eastbound East Euclid Avenue to the northbound entrance ramp.
- (2) At the intersection of Sixth Avenue and Mercy Drive, prohibiting left turns from westbound Mercy Drive to southbound Sixth Avenue, between 3:00 p.m. and 6:00 p.m.
- (3) At the intersection of Forty-second Street and Des Moines Freeway (Interstate Highway 235), prohibiting left turns from southbound Forty-second Street to the eastbound entrance ramp.
- (4) At the intersection of Southwest Ninth Street and Tuttle Street, prohibiting left turns from the southbound service road of Southwest Ninth Street to Tuttle Street.
- (5) Not used.
- (6) At the intersection of Hickman Road and Sixty-first Street, prohibiting left turns from eastbound Hickman Road to northbound Sixty-first Street, between 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday through Saturday.

- (7) At the intersection of Fleur Drive and Iowa Highway 5, prohibiting left turns from southbound Fleur Drive to the eastbound Iowa 5 entrance ramp, and prohibiting left turns from northbound Fleur Drive to the westbound Iowa 5 entrance ramp.
- (8) At the intersection of Iowa Highway 28 and Iowa Highway 5, prohibiting left turns from southbound Iowa 28 to the eastbound Iowa 5 entrance ramp, and prohibiting left turns from northbound Iowa 28 to the westbound Iowa 5 entrance ramp.
- (9) At the intersection of Forty-first Street and University Avenue, prohibiting left turns and through movements from southbound Forty-first Street to and/or across University Avenue.
- (10) At the intersection of East Diehl Avenue and a private driveway 220 feet west of Southeast Fourteenth Street, prohibiting left turns northbound from the driveway to East Diehl Avenue.
- (11) At the intersection of Fifty-seventh Street and a private driveway 350 feet north of Douglas Avenue, prohibiting left turns eastbound from the driveway to Fifty-seventh Street.
- (12) At the intersection of Grand Avenue and a private driveway 500 feet west of 19th Street, prohibiting left turns northbound from the driveway to Grand Avenue.
- (13) At the intersection of Grand Avenue and a private driveway 1,140 feet west of 19th Street, prohibiting left turns northbound from the driveway to Grand Avenue.
- (14) At the intersection of Forty-second Street and Chamberlain Avenue, prohibiting left turns and through movements from eastbound Chamberlain Avenue to and/or across Forty-second Street.

Sec. 114-361.01. Angle parking.

- (a) The initiation of angle parking at any location where such parking is not in existence is prohibited except at the following locations:
 - (1) Bridal Row, on the east side, from Fifteenth Street to Pleasant Street.
 - (2) Court Avenue, on the south side, from Water Street to Fifth Avenue.
 - (3) Keosauqua Way, on both sides, from Sixth Avenue to Seventh Street.
 - (4) East Hillside Avenue, on the south side, from Southeast Sixth Avenue to 240 feet west thereof.
 - (5) Murphy Street, on the south side, from Southwest Eleventh Street to 500 feet east thereof.
 - (6) East Market Street, on the south side, from Southeast Fifth Street to Southeast Sixth Street.
- (b) The initiation of back-in angle parking at any location is prohibited except at the following locations:
 - (1) Court Avenue, on the south side, from Water Street to East Third Street.
 - (2) Walnut Street, on the north side, from Water Street to East First Street.
 - (3) East Fourth Street, on the west side, from Locust Street to Grand Avenue.
 - (4) East Fourth Street, on both sides, from Grand Avenue to Des Moines Street.
 - (5) East Fifth Street, on the east side, from Walnut Street to Grand Avenue.
 - (6) Shaw Street, on the south side, from Southeast Fifth Street to Southeast Sixth Street.
 - (7) Twenty-third Street, on the west side, from Ingersoll Avenue to High Street.

(8) Chamberlain Avenue, on the north side, from Forty-second Street to a point 135 feet west thereof.

- (c) When signs are erected giving notice thereof, no person shall park a vehicle in any parking space designated for back-in angle parking except by positioning their vehicle entirely within the marked space, with the rear of the vehicle to the curb side of the street and the front of the vehicle to the traveled lanes of the street.
- (d) Angle parking shall be permitted to continue at locations where the distance between the painted centerline and the parking curb line is equal to or greater than the minimum requirement established by the following formula:

$$\text{Minimum Width from Centerline to Parking Curb line} = \text{VAVE}/400 \times 10' + 19'$$
- (e) The letters "VAVE" as used in the formula in subsection (b) of this section represent the average hourly volume of cars during the four highest hours of a day.
- (f) The cost of installing and maintaining facilities for angle parking shall be borne by the abutting property owners, and if they or any of them shall fail to refuse to do so, the city reserves the right to withdraw the privilege of this method of parking.
- (g) Nothing within this section shall prohibit parking by more than one motorcycle within one parking space as otherwise provided in this chapter.
- (h) A person who violates any provision of this section shall pay a fine of \$15.00.

Sec. 114-361.06. Public Library and Public Park lots.

- (a) No person shall park a vehicle in the underground reserved section of the main library parking lot at Tenth Street and Grand Avenue without authorization granted by the library director. All non-reserved parking spaces in this area are considered public parking spaces and is restricted to two hour parking only
- (b) No person shall park a vehicle in the paved parking lot immediately south of the branch library at 3516 Fifth Avenue after business hours. This lot is reserved for library customers only during business hours.
- (c) No person shall park a vehicle in the paved parking lot adjacent to the branch library at 5000 Franklin Avenue after business hours. This lot is reserved for library customers only during business hours.
- (d) No person shall park a vehicle in the paved parking lots immediately adjacent to the mid-city branch library at 1305 University Avenue and directly south of the branch library on the south side of University after business hours. These lots are reserved for library customers only during business hours.
- (e) No person shall park a vehicle in the paved parking lot on the east side of Second Avenue immediately southwest of the Women of Achievement Bridge after 11:00 p.m. This lot is restricted to two hour parking only during park hours.
- (ef) A person who violates any provision of this section shall pay a fine of \$15.00.

Sec. 114-1104. Parking after hours.

- (a) No person shall park a vehicle or allow a parked vehicle to remain in any public park, cemetery, community center or city recreational facility, except during the park facility hours set for that property in section 74-101 or in violation of section 114-361.06 of this

Code, unless special permission shall have been given by the parks and recreation director for such vehicle to remain there.

- (b) A violation of this section shall place such vehicle in the status of an illegally parked vehicle, and the vehicle may be dealt with pursuant to section 114-485.11 of this chapter.
- (c) A person who violates any provision of this section shall pay a fine of \$15.00.


