RESOLUTION AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO NEGOTIATE A DEVELOPMENT AGREEMENT BASED ON PRELIMINARY TERMS WITH PDM PRECAST, INC.

WHEREAS, PDM Precast, Inc. (hereinafter "PDM"), represented by Adam Petersen, its President, is seeking to purchase 29.89 acres of City-owned property at 3500 Vandalia Road for an expansion of its existing precast concrete manufacturing facility at 3312 E. Granger Avenue; and,

WHEREAS, PDM is an existing Des Moines based precast concrete and metal fabrication business with its headquarters at 622 SE 6th Street in the East Village, a precast concrete fabrication facility at 3312 E. Granger Avenue in the SE AgriBusiness Urban Renewal Area, and a steel fabrication facility in Carlisle; and,

WHEREAS, on May 21, 2018, by Roll Call No. 0888, the City Council directed the Economic Development Director to negotiate with PDM on an agreement for the sale and redevelopment of the City-owned property; and,

WHEREAS, the Economic Development Director has negotiated preliminary terms of agreement with PDM whereby the land would be sold for a purchase price of \$40,000 per acre, subject to the following adjustments and discounts:

- 1. Four (4) acres of the property are located within a ditch and would be considered to have no value;
- 2. The purchase price would be discounted by 30% in consideration of the undertaking by PDM to construct a new 45,500 square foot building on the property for the relocation of its steel fabrication facility into Des Moines within three years, and to construct an additional 80,000 square foot building on the property or at the existing PDM facility at 3312 E. Granger Avenue for a further expansion of its precast concrete manufacturing facility within ten years;
- 3. Potentially an additional discount to be negotiated, due to extraordinary development costs that still need to be defined and reviewed; and,
- 4. With all such discounts to be subject to recapture if the new buildings and business expansion do not occur as planned.
