SUBJECT: FY20 Highland Park SSMID

The Highland Park Self Supported Municipal Improvement District (SSMID) has an active SSMID board that met on January 29th, 2019 to review and discuss their budget for the coming year. Below is a summary of the Highland Park SSMID for the FY20 budget year.

- Taxable Valuation for the District is \$7,186,399
- SSMID levy rate for the District is \$1.75/\$1,000 of taxable valuation
- Estimated revenue for FY20 is \$13,847 (including State Replacement Credit)
- Anticipated expenditures for FY20 is \$10,660
- Current Fund Balance is \$57,841

The Highland Park SSMID board recommends continuation of the SSMID levy at the current rate of \$1.75 per \$1,000 valuation for the FY20 budget year. The Highland Park SSMID will continue to provide for the maintenance of the streetscape improvements within the district.
