RESOLUTION AUTHORIZING THE ISSUANCE OF \$49,845,000 GENERAL OBLIGATION BONDS, SERIES 2019A, AND LEVYING A TAX FOR THE PAYMENT THEREOF

WHEREAS, the City of Des Moines, State of Iowa ("Issuer"), is a municipal corporation, organized and existing under the Constitution and laws of the State of Iowa, and is not affected by any special legislation; and

WHEREAS, the Issuer is in need of funds to pay costs of various capital improvement projects and has held hearings totaling the amount of not to exceed \$82,120,000.

WHEREAS it is deemed necessary and advisable that General Obligation Bonds, Series 2019A, in the amount of \$49,845,000 be issued for some or all of the projects; and

WHEREAS, the City Council has taken such acts as are necessary to authorize issuance of the Bonds.

NOW, THEREFORE, IT IS RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, STATE OF IOWA:

Section 1. <u>Authorization of the Issuance</u>. General Obligation Bonds, Series 2019A, in the amount of \$49,845,000 shall be issued pursuant to the provisions of Iowa Code Sections 384.25, 384.26, 384.28 and 403.12 for the purposes covered by the hearing.

Section 2. <u>Levy of Annual Tax</u>. For the purpose of providing funds to pay the principal and interest as required under Chapter 76.2, there is levied for each future year the following direct annual tax upon all the taxable property in the City of Des Moines, State of Iowa, to wit:

Section 3. <u>Amendment of Levy of Annual Tax</u>. Based upon the terms of the future sale of the Bonds to be issued, this Council will file an amendment to this Resolution ("Amended Resolution") with the County Auditor.

Section 4. Filing. A certified copy of this Resolution shall be filed with the County Auditor of County of Polk, State of Iowa, who shall, pursuant to Iowa Code Section 76.2, levy, assess and collect the tax in the same manner as other taxes and, when collected, these taxes shall be used only for the purpose of paying principal and interest on the Bonds.
