## RESOLUTION APPROVING PRELIMINARY TERMS OF AGREEMENT WITH JR PARTNERS, LLC, FOR HISTORIC RENOVATION AND REDEVELOPMENT OF A BUILDING LOCATED AT 401 E. COURT AVENUE

WHEREAS, JR Partners, LLC (Tim Rypma, Jeremy Cortright and Paul Cownie, Members, 102 Court Avenue, Suite 204, Des Moines IA 50309) is proposing a \$3 million historic renovation of a 1-story, approximately 10,700-square-foot commercial building located at 401 East Court Avenue. The building was originally constructed in 1940 as the first purposebuilt A&P Super Market in Des Moines; and,

WHEREAS, renovating and repurposing the buildings for new uses will enhance the commercial vitality of the Historic East Village further south and the renovated building will contain three separate commercial tenant bays potentially for retail and restaurant and other uses; and,

WHEREAS, the Development team is seeking federal and state historic tax credits and is working with the State Historic Preservation Office (SHPO) on design requirements; and,

WHEREAS, under the presently proposed terms, the project would receive tax increment financing on a declining schedule of project generated tax increment in years 1-5 of 90%, years 9 of 85%, years 10-12 of 80% and years 13-15 of 75% of the project generated tax increment on the building; and,

WHEREAS, the developer has provided the Office of Economic Development with a financial analysis of the project, indicating a gap between actual project costs and the project appraisal and seeks a financial assistance package to be provided from project generated tax increment as more specifically described in the accompanying Council Communication.
