## HONORABLE MAYOR AND MEMBERS OF THE DES MOINES CITY COUNCIL

Re: Report to Council

Pursuant to the authority and direction of Council authorizing the City Attorney to settle claims, lawsuits and workers' compensation actions for a total sum not to exceed \$5,000, I submit to Council the following summary report of settlements made:

TRAVIS BIDDLE, \$1,191.00 in payment of claim filed December 20, 2018. Claimant had been billed for a second garbage toter at 4027 41<sup>st</sup> Street from February 2009 through November 2018; a second toter was never delivered by the City.

JASON HESS, \$4,224.82 for property damage claim of October 27, 2018 when there was a blockage in the City main which caused a sewer backup in claimant's basement at 2808 Hull Avenue.

MIDAMERICAN ENERGY, \$172.64 for damage to an overhead wire that was struck by a yard waste collection truck on November 12, 2018 at 2606 46<sup>th</sup> Street.

MARS COFFEE BAR, \$241.00 for property damage when Traffic and Transportation employee emptying change from the meters broke claimant's sign on November 20, 2018.

MISAEL HERNANDEZ, \$776.13 in payment of property damage claim of November 28, 2018 when City driver backed into claimant's vehicle that was parked at 2410 56<sup>th</sup> Street.

DAWN THORPE, \$478.98 in payment of claim of December 1, 2018 when claimant was exiting a parking spot on the southwest corner of E. Grand Avenue and East 6<sup>th</sup> Street and struck the stub of a post, resulting in two flat tires. City crews previously removed the damaged post of the road sign but did not remove the stub portion which was bolted into the right-of-way.

NORMA BOYLAN, \$329.00 for damage to claimant's property when Fire EMS crew struck a statue with a gurney on December 2, 2018 at 3120 East Douglas Avenue.

BRUCE AND DEBBIE MILLER, \$570.38 for property damage resulting from incident of December 23, 2018 when a blockage in the City main caused a sewage backup at 2511 Morton Avenue. A second claim at 2511 Morton for \$127.98 for property damage was as the result of a second obstruction in the main that caused another backup of sewage into the basement on February 2, 2019.

TODD ADAMSON, \$30.00 (ordinance claim limit) in payment of claim of January 14, 2019 when snowplow struck claimant's mailbox at 3204 Hubbell Avenue.

DAVID AND JENNIFER NUTTING, \$30 for damage to mailbox struck by a snowplow on January 22, 2019 at 404 East Park Avenue.

LINDA REYNOLDS, \$30.00 for damage to mailbox that was struck by a snowplow on January 23, 2019 at 7906 S.W. 9<sup>th</sup> Street.

CHESTER CLUKE, \$1,820.63 for vehicle damage when snowplow struck parked car in the 2600 block of Columbia Street on January 23, 2019.

MICHAEL PRIEBE, \$1,446.26 in payment of claim in which a fire engine struck a parked vehicle on January 31, 2019 on College Avenue at 33<sup>rd</sup> Street.

BRYANT WHEELER, \$1,424.38 in payment of claim of February 8, 2019 when snow plow struck illegally parked car at 714 27<sup>th</sup> Street; the City claim was reduced by 50% due to Claimant's illegal parking while the snow ordinance was in effect.

BRET AND SUSAN DEVRIES, \$30.00 for damage to mailbox that was struck by a snowplow on February 11, 2019 at 4112 S.E. 24<sup>th</sup> Court.

KRIS FLEURESTIL, \$2,173.50 in payment of property damage claim of February 18, 2019 when snowplow struck illegally parked vehicle at 3100 Madison Avenue; claim was reduced by 50% due to illegal parking by claimant.

SCOTT AND SARAH WILSON, \$329.39 in payment of claim of February 20, 2019 when snowplow struck parked car at 1501 57<sup>th</sup> Place.

RICK PERSINGER AND LESLIE YOUNG, \$30.00 to replace a mailbox that was struck by a snowplow on February 20, 2019 at 5513 S.E. 29<sup>th</sup> Street.

SEVMEA CHE, \$672.04 for property damage resulting from incident of February 24, 2019 when police car backed into parked vehicle at QuikTrip.

DAVID KLINE, \$272.00 in payment of property damage claim when snowplow struck claimant's vehicle and broke the side mirror on February 24, 2019 at 1801 East 32<sup>nd</sup> Court.

BILL AND DEBORAH CHILES, \$30 in payment for mailbox that was damaged by snowplow on February 24, 2019 at 2115 Evergreen.

NICO HARRIS, \$4,188.75 for repairs to claimant's vehicle resulting from incident of February 26, 2019 when end loader was moving snow and backed into vehicle on Kingman Blvd. at 25<sup>th</sup> Street.
