APPROVAL OF DONATION, CONSTRUCTION AND MAINTENANCE AGREEMENT BETWEEN CENTRAL IOWA TRAIL ASSOCIATION, INC. AND CITY OF DES MOINES REGARDING ADVANCED LOOP MOUNTAIN BIKE TRAIL IN EWING PARK

WHEREAS, the Park and Recreation Department is charged with the responsibility of providing recreational activities, including mountain biking trails, within the City of Des Moines; and

WHEREAS, Central Iowa Trail Association, Inc. (CITA) has proposed, and is engaged in a private fundraising effort for, constructing and funding of an advanced loop addition to the mountain bike trail in Ewing Park, estimated to be in the amount of \$15,000, and which plans and specifications must be approved by the Director of Parks and Recreation in order to be put into effect (the "Advanced Loop"); and

WHEREAS, CITA also proposes to be responsible for maintenance of the Advanced Loop; and

WHEREAS, CITA desires to make a charitable contribution for the benefit of the citizens in the central Iowa region, of the Advanced Loop to the City of Des Moines upon completion and acceptance by the Director of Parks and Recreation; and

WHEREAS, Park and Recreation Department staff and CITA have negotiated a Donation and Construction and Maintenance Agreement Between the City of Des Moines and Central Iowa Trail Association, Inc. For Advanced Loop at Ewing Park Mountain Bike Trail, a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the Donation, Construction and Maintenance Agreement Between the City of Des Moines and Central Iowa Trail Association, Inc. For Advanced Loop at Ewing Park Mountain Bike Track, a copy of which is available in the City Clerk's Office, is hereby approved and the Mayor is authorized and directed to sign the agreement on behalf of the City and the City Clerk is authorized and directed to attest to his signature.
