## RESOLUTION APPROVING ISSUANCE OF CERTIFICATE OF COMPLETION TO NEXUS AT GRAY'S LANDING LLC FOR THE NEXUS AT GRAY'S LANDING APARTMENTS AT 415 SW 11th STREET

WHEREAS, on October 8, 2007, by Roll Call No. 07-1991, the City Council approved an *Amended and Restated Urban Renewal Development Agreement* (the "Master Agreement") with River Point West LLC (the "Developer") represented by George Sherman, whereby the Developer agreed to acquire all the land within a designated portion of the Riverpoint West Area including the parcel at 415 SW 11th Street described below, to install all necessary public infrastructure, and to clear and prepare the land for redevelopment in accordance with an approved Conceptual Development Plan; and,

WHEREAS, on May 18, 2015, by Roll Call No. 15-0824, the City Council approved a Parcel Development Agreement with Nexus at Gray's Landing LLC (the "Owner") represented by George Sherman, whereby the Owner agreed to purchase the parcel at 415 SW 11th Street from Developer, and to construct a 142-unit apartment building on the parcel with off-street parking and landscaping (collectively the "Improvements") in accordance with an approved Redevelopment Plan; and,

WHEREAS, the Improvements to the parcel at 415 SW 11th Street have been completed in substantial compliance with the Parcel Development Agreement and the approved Redevelopment Plan; and,

**WHEREAS**, the Owner has requested the City issue a Certificate of Completion as evidence of Developer's satisfaction of its construction obligation under the Parcel Development Agreement.

**NOW THEREFORE, BE IT RESOLVED,** by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council hereby finds and acknowledges that as of December 31, 2017, Nexus at Gray's Landing LLC has satisfied its obligation to complete the construction of the Improvements at 415 SW 11th Street, more specifically described as follows, in substantial compliance with the Parcel Development Agreement and the approved Redevelopment Plan. This resolution shall serve as the Certificate of Completion to be issued by the City pursuant to Section 1.7 of the Parcel Redevelopment Agreement recorded on June 2, 2015, in Book 15598, at Page 50, in the land recorded of the Polk County Recorder.
