APPROVING BANK ON CENTRAL IOWA PROGRAM TRANSITION TO THE EVELYN K. DAVIS CENTER

WHEREAS, on August 23, 2010, by Roll Call No. 10-1399, the City Council of the City of Des Moines, Iowa referred to the City Manager to assign staff to coordinate a Bank On program; and

WHEREAS, pursuant to said Council direction, the Des Moines Community Action Agency Division worked with local non-profits and financial institutions to develop a local Bank On initiative entitled Bank On Central Iowa; and

WHEREAS, on May 18, 2015, by Roll Call No. 15-871, the City Council approved the Assumption Agreement by and between the City of Des Moines and the Red Rock Area Community Action Program, now known as Impact Community Action Partnership, for the conveyance of the Des Moines Community Action Agency programs and service area; and

WHEREAS, due to said assumption, administration of the Bank On Central Iowa program was transferred from the Des Moines Community Action Agency to the City of Des Moines, Iowa Municipal Housing Agency; and

WHEREAS, the Evelyn K. Davis Center has infrastructure to connect individuals to financial education and asset building through the Bank On Central Iowa program in a manner that will be more effective than the City's Municipal Housing Agency; and

WHEREAS, the Evelyn K. Davis Center will accept a resolution from the City Council of the City of Des Moines, Iowa as the formal agreement to transition leadership, administration, and obligations of the Bank on Central Iowa program.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the transition of the Bank on Central Iowa Program to the Evelyn K Davis Center is hereby approved; that all administration, program balances, and obligations of said Program are hereby assigned and transferred from the City of Des Moines, Iowa Municipal Housing Agency to the Evelyn K. Davis Center; and that the Finance Department is authorized to transfer and pay the Program balance in the amount of \$9,644.69 to the Evelyn K. Davis Center.
