

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2618, 114-2639, 114-2661, 114-2829, 114-3071, 114-3344, 114-3464, 114- 3504 and 114-3799, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2618, 114-2639, 114-2661, 114-2829, 114-3071, 114-3344, 114-3464, 114- 3504 and 114-3799, relating to traffic and vehicle regulations, as follows:

Sec. 114-2618. Fourth Street--Grand Avenue to Watson Powell Jr Way.

~~Fourth Street, on the west side, from Grand Avenue to a point 50 feet north thereof, no parking any time.~~

Fourth Street, on the west side, from a point 50 feet north of Grand Avenue to a point 40 25 feet north thereof, commercial loading zone.

Fourth Street, on the east side, from a point 100 feet north of Grand Avenue to a point 25 feet north thereof, commercial loading zone.

~~Fourth Street, on the east side, from a point 210 feet north of Grand Avenue to a point 55 feet north thereof, commercial loading zone.~~

~~Fourth Street, on the east side, from a point 265 feet north of Grand Avenue to a point 95 feet north thereof, no parking any time.~~

Fourth Street, on the west side, from a point 50 feet south of Watson Powell Jr Way to a point 35 feet south thereof, loading zone.

Sec. 114-2639. Sixth Avenue--Cherry Street to Mulberry Street.

Sixth Avenue, on the west side, from Cherry Street to a point 145 150 feet north thereof, reserved for sheriffs no parking any time.

~~Seventh Street, on the west side, from Mulberry Street to a point 85 feet south thereof, no parking any time.~~

~~Seventh Street, on the west side, from a point 85 feet south of Mulberry Street to a point 100 feet north of Cherry Street, no parking 7:00 a.m. to 9:00 a.m. and 3:00 p.m. to 6:00 p.m.~~

Seventh Street, on the east side, from Vine Street to Cherry Street, no parking any time.

Sec. 114-2829. Twenty-fifth Street--Woodland Avenue to Payne Road.

Twenty-fifth Street, on the west side, from Woodland Avenue to a point 40 feet north thereof, no parking any time.

Twenty-fifth Street, on the east side, from Woodland Avenue to a point 65 feet north thereof, no parking any time.

Twenty-fifth Street, on the east side, from Center Street to a point 300 feet north of Rollins Avenue, no parking any time.

Twenty-fifth Street, on the east side, from School Street to a point 120 feet south thereof, and any part of the cul-de-sac, no parking any time.

Twenty-fifth Street, on the west side, from Cottage Grove Avenue to a point 50 feet north of Cottage Grove Avenue, no parking any time.

Twenty-fifth Street, on the east side, from Cottage Grove Avenue to a point 80 feet north thereof, no parking any time.

Twenty-fifth Street, on the east side, from a point 15 feet north of Cottage Grove Avenue to Kingman Boulevard, no parking any time.

Twenty-fifth Street, on the east side, from University Avenue to a point 90 feet north thereof, two-hour parking, 9:00 a.m. to 4:00 p.m.

Twenty-fifth Street, on the east side, from a point 90 feet north of University Avenue to a point 40 feet north thereof, loading zone.

Twenty-fifth Street, on the east side, from a point 130 feet north of University Avenue to a point 560 feet south of Forest Avenue, two-hour parking, 9:00 a.m. to 4:00 p.m.

Twenty-fifth Street, on the east side, from a point 180 feet north of University Avenue to a point 20 feet north thereof, is designated a handicapped parking space and is subject to the same prohibition as is found in section 114-616(a) of this Code.

Twenty-fifth Street, on the east side, from a point 560 feet south of Forest Avenue to a point 140 feet north thereof, no parking any time.

Twenty-fifth Street on the east side, from a point 420 feet south of Forest Avenue to a point 220 feet north thereof, two-hour parking, 9:00 a.m. to 4:00 p.m.

Twenty-fifth Street, on the east side, from Forest Avenue to a point 205 feet south thereof, no parking any time.

Twenty-fifth Street, on the west side, from Forest Avenue, to a point 135 feet north thereof, no parking any time.

Twenty-fifth Street, on the east side, from Forest Avenue to Clark Street, no parking any time.

Twenty-fifth Street, on the west side, from Clark Street to a point 50 feet south thereof, no parking any time.

Twenty-fifth Street, on the west side, from Sheridan Avenue to Payne Road, no parking any time.

Twenty-fifth Street, on the east side, from Prospect Road (east leg) to a point 50 feet south thereof, no parking any time.

Twenty-fifth Street, on the east side, from Payne Road to a point 50 feet south thereof, no parking any time.

Sec. 114-3071. Cherry Street--Sixth Avenue to Seventh Street.

Cherry Street, on the south side, from Sixth Avenue to a point 55 feet west thereof, no parking any time.

Cherry Street, on the south side, from a point 55 feet west of Sixth Avenue to a point 68 feet west thereof, commercial loading zone.

Cherry Street, on the south side, from a point 123 feet west of Sixth Avenue to a point 28 feet west thereof, no parking any time, passenger loading and unloading only.

Cherry Street, on the south side, from a point 151 feet west of Sixth Avenue to a point 40 feet west thereof, no parking any time.

Cherry Street, on the south side, from Seventh Street to a point 24 feet east thereof, no parking any time.

~~Cherry Street, on the north side, from a point 60 feet west of Sixth Avenue to a point 145 feet west thereof, reserved for sheriffs.~~

Sec. 114-3344. Ingersoll Avenue--Twenty-eighth Street to Thirty-fifth Street.

Ingersoll Avenue, on the north side, from Twenty-eighth Street to a point 90 feet east of Twenty-ninth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Ingersoll Avenue, on the north side, from a point 90 feet east of Twenty-ninth Street to a point 40 feet west of Twenty-ninth Street, no parking any time.

Ingersoll Avenue, on the north side, from a point 190 feet west of Twenty-ninth Street to a point 50 feet west thereof, is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

~~Mulberry Street, on the north side, from a point 160 feet west of Fifth Avenue to Sixth Avenue, no parking any time.~~

Mulberry Street, on the south side, from a point 150 feet west of Fifth Avenue to a point 50 feet west thereof, commercial loading zone. ~~Fifth Avenue to a point 55 feet west thereof, no parking any time.~~

Sec. 114-3799. Woodland Avenue--Martin Luther King Jr Parkway to Twenty-eighth Street.


